Program Terms and Conditions

PART A: General Conditions

Administration

1. The Water Efficiency Equipment Replacement Incentives and all portions thereof (the "Incentives") will be administered by the Regional Municipality of York and its agents (the "Region").

Eligible Facilities

- 2. To be eligible for consideration for the Incentives, the facility must be an "Eligible Facility".
- 3. For the purposes of the Incentives, to be considered an "Eligible Facility", the facility must:
 - a) be located within the geographical area of the Region;
 - b) have a water account administered by a local municipality within the Region;
 - c) be connected to a municipal water supply; and
 - d) be classified by the Region as an industrial, commercial, or institutional building or multi-unit properties (e.g., office, retail outlet, hotel, hospital, factory, warehouse, manufacturing, government, school, multi-unit residential property operated by property management company, etc.).

Eligible Equipment

- 4. Equipment within an Eligible Facility that may be eligible for replacement or retrofit under the Incentives program must:
 - a) be purchased and installed on an Eligible Facility (equipment purchased for new construction does not qualify);
 - b) be of similar capacity and function to equipment removed or retrofitted; and
 - c) Consist of one of the following:
 - I) replacement of a non-WaterSense[®] labelled shower head with a WaterSense[®] labelled unit or higher efficiency unit (7.6 LPM or less),
 - II) replacement of a non-WaterSense® labelled toilet with a WaterSense® labelled unit or higher efficient unit (4.8 LPF or less),
 - III) replacement of a non-WaterSense® labelled Urinal with a WaterSense® labelled unit or higher efficient unit (1.9 LPF or less),
 - IV) replacement of a non-WaterSense[®] labelled pre-rinse spray valve with a WaterSense[®] labelled valve or higher efficient unit (4.8 LPM or less),
 - V) installation of a new dipper well faucet that has a flow rate equal to or less than 1 gallon per minute (or 3.79 liters per minute). If the dipper well is one piece, replace the entire unit. If it is two separate pieces, replace the faucet only,
 - VI) replacement of a water-cooled ice machine with air-cooled unit at the same facility,
 - VII) replacement of a water-cooled packaged condenser with air-cooled unit at the same facility,
 - VIII) replacement of a liquid ring dental vacuum pump with one that does not use water to create suction,
 - IX) installation of pH or conductivity controller on an existing cooling tower,
 - X) installation of AWWA certified sub meter, or
 - XI) equipment otherwise deemed eligible by the Region.

Acceptance of Applicant

- 5. The Region reserves the right to accept or reject, in its sole discretion, any application or any part thereof.
- 6. As Regional funding and/or resources are limited, applications will be processed on a first-come-first-served basis.
- 7. The Incentives are subject to the Region allocating, in its sole discretion, funding and resources adequate to support the Incentives program.

General Conditions

- 8. At any time and for any reason, the Region may in its sole discretion refuse any or all further applications for the incentives, may extend the deadline for applications for the incentives or any other deadline, or terminate the Incentives, all in the Region's sole discretion.
- 9. The Applicant shall at all times adhere to any and all federal, provincial, and municipal laws and by-laws at all times.
- 10. Each Applicant must be in compliance with the Region's Sewer Use Bylaw, as may be amended or replaced.
- 11. For greater certainty, the failure of an Applicant or facility, or both, to meet any or all conditions of the Incentives may result in refusal or disentitlement to any rebate payment.



Disclaimer and Release

The Applicant hereby releases and forever discharges each and all of the Region and its elected officials, officers, employees, agents, and invitees (collectively, the "Region Releasees") from and against any and all claims, costs or demands whatsoever that the Applicant may now or ever have against the Releasees in relation to any loss, damage or injury (including death) that may occur indirectly, directly, or consequently as a result of or arising from or relating to the Applicant's participation in the Incentives, including but not limited to the work or activities conducted in relation thereto.

Indemnity Clause

The Applicant shall at all times defend, indemnify and save harmless each and all of the Region, elected officials, its officers, agents, employees, and invitees (collectively, the "Region Indemnitees") from and against any and all manner of claims, demands, losses, cost, charges, actions and other proceedings whatsoever made or brought against, suffered by or imposed on the Region Indemnitees or their property in respect of any loss, or damage or injury (including death) to any person or property directly or indirectly arising out of, resulting from or relating to the Applicant's participation in the Program or any act or omission of the Applicant in connection with or in relation to its participation in the Incentives, including, without limitation, the installation and operation of any equipment at the Applicant's facility.

PART B: Program Conditions

Description

12. The Incentives provides a Regional contribution to help offset the capital costs incurred by an Applicant for the replacement of the inefficient water equipment to water efficient technology that results in a long-term reduction in water consumption.

Conditions for Acceptance

- 13. The Applicant shall include the following documentation in each application for the Incentives:
 - a) A completed application form;
 - b) Existing inefficient equipment photo(s);
 - c) New water efficient equipment specification and installation photo(s);
 - d) Copy of Proof of Purchase document (original invoice) clearly indicating:
 - I) Business name;
 - II) Installation address and contact information of retailer and/or contractor;
 - III) Date of purchase of the new equipment or date of the upgrade;
 - IV) Manufacturer and model number of qualifying new equipment or upgrades made.

Applicant's Responsibility

- 14. Each participating Applicant must provide the Region with access to their facility to verify the installation of the new equipment, technology, or process change if the Region so requests.
- 15. Each participating Applicant must assume all financial and other responsibility in relation to the purchase and installation of the new equipment/technology to reduce water use, including any preparatory and repair work that is required for the proper installation of this new equipment/ technology.

Proof of Compliance and Conditions for Payment

- 16. Payment to the Applicant (purchaser of equipment) under the Incentives will be conditional upon submission by the Applicant of original proof of purchase and installation of any new equipment/technology dated after the start date of the program.
- 17. Unless otherwise specified by the Region, the amount of the one-time payment for the Incentive will be calculated as specified at york.ca/waterincentives, as amended.

By awarding an Incentive to an Applicant, the Region does not represent or warrant in any way whatsoever the quality or condition of workmanship, the suitability of the premises or the equipment for installation or replacement, or that the performance of any equipment/upgrades or the installation thereof will be free of defects. The Region reserves the right to alter, cancel or discontinue the Incentives at any time and to reverse the rebate if the information provided by the applicant is either incorrect, or untrue, or if the Terms & Conditions of the Incentives have not been met. Applicant must agree to onsite verification if requested by the Region, prior to approval of the Incentives rebate. The Region reserves the right to inspect the installation of new equipment installed or upgrades made.
