Important message for Parents/Guardians/Students

YOUR CHILD'S IMMUNIZATION INFORMATION REQUIRED THIS FALL

Dear Parents/Guardians/Students,

Immunization against vaccine-preventable diseases is a cornerstone of a safe and healthy school environment. Every year, York Region Public Health (YRPH) collects and reviews the immunization information of students in York Region to ensure each child's immunizations are up-to-date according to [Ontario's Immunization Schedule](#).

During the COVID-19 pandemic, YRPH paused the collection and review of immunization data and did not enforce the [Immunization of School Pupils Act](#) (ISPA) which requires all children attending school in Ontario to be immunized against certain vaccine-preventable diseases. **Starting the 2023-24 school year, YRPH will be reintroducing the enforcement of the *Immunization of School Pupils Act* (ISPA).**

Your child's doctor or school does **not** provide immunization information to us. **It is the parent/guardian's responsibility to provide immunization information to YRPH** and update us every time your child gets vaccinated through our easy-to-use online portal (link below).

We know that most York Region students did receive their required immunizations during the pandemic. However, **if your child's immunization record is not up to date in our information system, your child may be suspended from school** until the updated immunization record is submitted. Please update your child's immunization information in our system as soon as possible.
