RESOLUTION

57 **Police By-law re: Paid Duty Administration**

WHEREAS pursuant to section 220.1 of the Municipal Act, a Police Services Board may enact by-laws to impose fees and charges for services and activities provided to the public or done by it and for the use of its property;

WHEREAS on February 23, 2000 the Police Services Board passed a by-law to further amend By-law No. 8-96 being a fee by-law which imposes fees and charges for services and activities provided by the York Regional Police; and

WHEREAS section 220.1(8) requires the municipality to approve, by resolution, the by-law;

THEREFORE BE IT RESOLVED THAT Council of The Regional Municipality of York approve By-law No. 03-00, a by-law to further amend By-law No. 8-96 being a

by-law to impose fees and charges for services and activities provided by the York Regional Police.
