YORK REGION TRANSIT SET FINE SCHEDULE FOR TRANSIT BY-LAW R-1415-2005-018

The Transportation and Works Committee recommends the adoption of the recommendation contained in the following report dated June 4, 2009, from the Commissioner of Transportation Services and the Regional Solicitor.

1. RECOMMENDATION

It is recommended that:

1. Regional Council approve the recommended set fines itemized in bold in *Attachment I* and direct staff to make application to the Regional Senior Justice to approve required additions to the set fine schedule for Transit By-law R-1415-2005-018, as amended.

2. PURPOSE

This report recommends the approval of the set fine schedule for Transit By-law R-1415-2005-018, as amended.

3. BACKGROUND

In September 2008, Regional Council authorized amendments to Transit By-law R-1415-2005-018 and directed the Regional Solicitor to prepare an amending by-law (Clause 1, Report No. 6 of the Transit Committee). Those amendments include the creation of new offence provisions, as well as housekeeping amendments to add clarity and provide for more effective enforcement. The new offence provisions include provisions specific to parking enforcement, which will apply to commuter parking at transit stations, such as the new South Keswick Commuter Parking Lot.

The amending by-law will be presented to Regional Council for enactment on June 25, 2009. Following enactment, the set fines applicable to the new provisions will require approval by the Regional Senior Justice.

The existing schedule of set fines for Transit By-law R-1415-2005-018 was approved by the Regional Senior Justice on September 21, 2005. Revisions to the Set Fine Schedule are now required as a result of the amendments to Transit By-law R-1415-2005-018.

4. ANALYSIS AND OPTIONS

The Set Fine Schedule for Transit By-law R-1415-2005-018 has been revised pursuant to the amendments to the by-law authorized by Regional Council and incorporated in an amending by-law to be presented on June 25, 2009. The recommended fines are listed in bold on *Attachment 1*. The existing fines are shown for comparative purposes but no amendments to these amounts are recommended at this time. The recommended fines are consistent with fines in place for other transit systems in the Greater Toronto Area.

5. FINANCIAL IMPLICATIONS

There are no significant financial implications for the Region arising from the revised set fine schedule. The new offence provisions and associated fines will enable more effective enforcement and may result in an increase in fine revenues.

About \$150,000 - \$200,000 per year in collected fine revenue is transferred from the Provincial Courts System. Amounts received are used to offset program costs for the Enforcement Unit.

6. LOCAL MUNICIPAL IMPACT

Local municipalities will continue to benefit from a transit service that assesses and improves the operation of its transit system.

7. CONCLUSION

Staff recommends the approval of the revised Set Fine Schedule listed in bold in *Attachment 1* to this report.
