**2. York Region Transit 2009 Fare Rate Change 11**

1. The proposed fare structure summarized below and identified in this report as Option 3 be endorsed for implementation effective January 1, 2009.
  - Adult – 10 tickets \$ 26.00
  - Student – 10 tickets \$ 19.00
  - Senior/Child – 10 tickets \$ 15.00
  - Express Cash \$ 3.50
  - Express – 10 tickets \$ 32.50
  - Student Monthly Pass \$ 75.00
  - Multipass \$105.00
  - Senior\Child Pass \$ 46.00
  - Express Pass \$125.00
2. All other fare categories remain at 2008 values.
