The *Health Protection and Promotion Act* (HPPA) governs boards of health in Ontario



- The HPPA is the principal legislation that governs public health in Ontario
- The Act and its Regulations deal with regulatory matters as they pertain to public health

The HPPA includes important information about boards of health



- ❑ The definition of a board of health
- ❑ The role and mandate of a board of health

A board of health is a governing body that governs an area of jurisdiction – “the health unit”



- ❑ The HPPA requires that every health unit have a board of health
- ❑ Boards of health can be independent boards of health or municipal corporations (e.g. York Region)

The statutory mandate of boards of health



- ❑ In accordance with the HPPA, every board of health must ensure the provision of the health programs and services required under the Act to residents of the health unit
- ❑ The Minister of Health and Long-Term Care publishes guidelines for the provision of mandatory health programs and services

The role of the Medical Officer of Health is set out in the HPPA



- The Medical Officer of Health is responsible for the management of public health programs and services
- The Medical Officer of Health has powers to issue orders under the HPPA
- The Medical Officer of Health is selected by the board of health and approved by the Minister of Health and Long-Term Care

Core functions of public health include preventing disease, protecting and promoting health



- ❑ Prevention of diseases and injuries
- ❑ Control of infectious and reportable diseases
- ❑ Protection from health hazards
- ❑ Promotion of health
- ❑ Monitoring health status
- ❑ Evaluating public health services
- ❑ Researching public health problems

Standards identify board of health outcomes for each program area

Example: Tuberculosis Prevention and Control

GOAL:

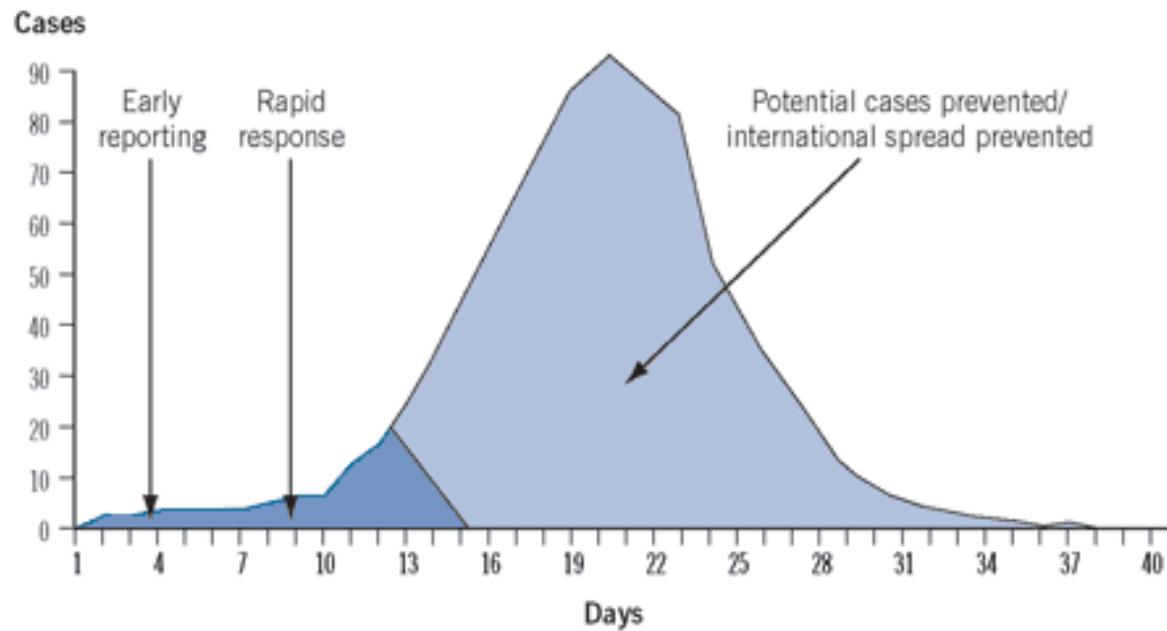
To prevent or reduce the burden of tuberculosis (TB)

BOARD OF HEALTH OUTCOMES:

- ❑ Public health risks associated with active TB are mitigated
- ❑ Individuals with infectious TB are isolated
- ❑ Individuals with active TB (cases) receive the appropriate medication
- ❑ Individuals with active TB or LTBI are identified
- ❑ Individuals with LTBI are offered appropriate treatment



Impact of public health action



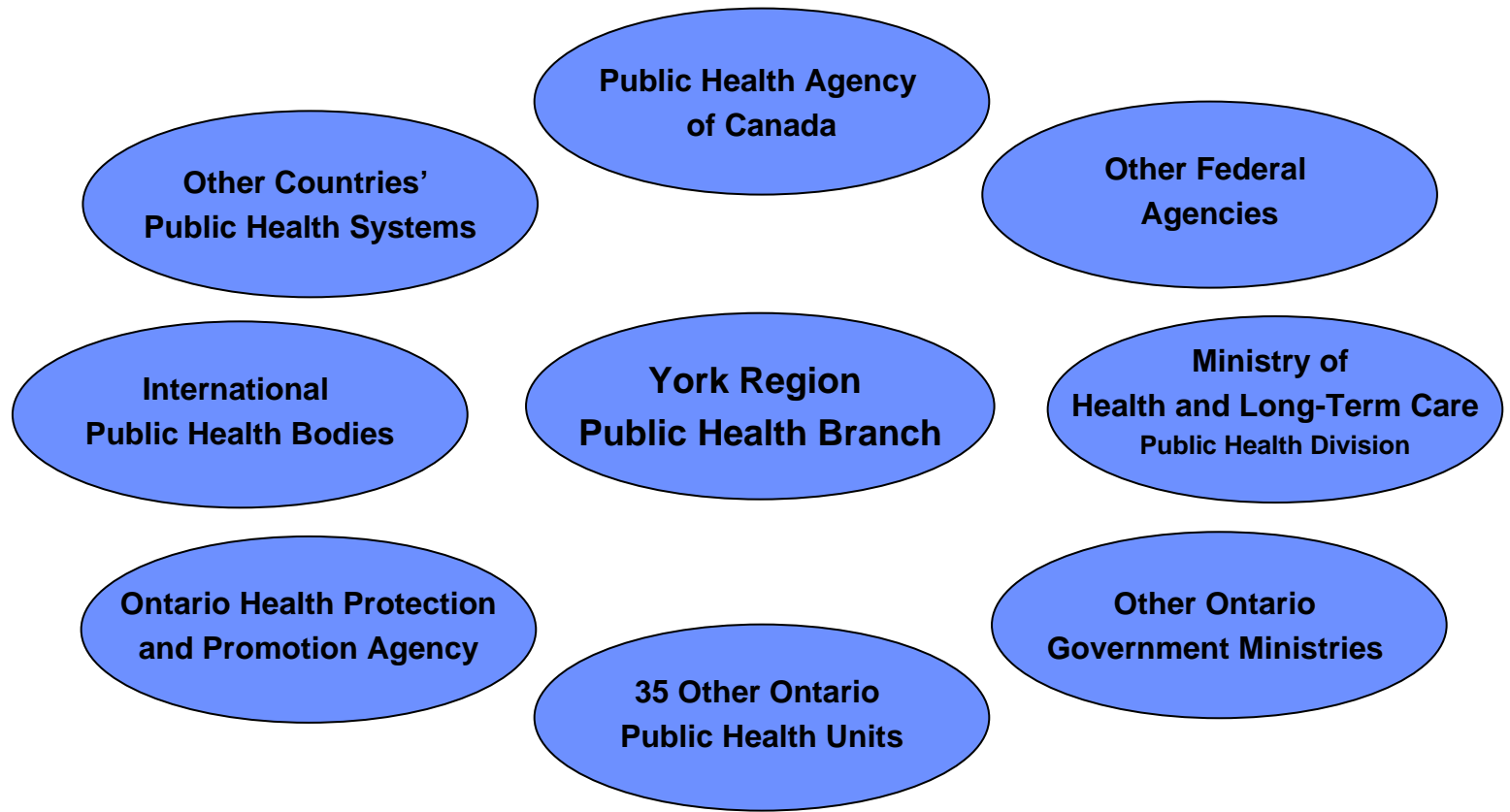

- ❑ Reports to Committee and Council
- ❑ Presentations to Committee
- ❑ Responses to specific queries from Councillors
- ❑ Performance indicators

MOHLTC and LHIN : Areas of Responsibility

MOHTLC

- ❑ Public Health
- ❑ Ambulance services
- ❑ Laboratories
- ❑ Provincial drug programs
- ❑ Provincial programs
- ❑ Individual practitioners and Family Health Teams
- ❑ Independent Health Facilities

LHIN

- ❑ Hospitals
- ❑ Community Care Access Centres (CCACs)
- ❑ Long-term care facilities
- ❑ Community health centres
- ❑ Community support service organizations (e.g. personal assistance services, homemaking, friendly visiting)
- ❑ Addictions & mental health agencies
