April 7, 2003, recommending that:

1. Regional staff be authorized to give notice to refuse the request made by 1207309 Ontario Inc. to amend the Regional Official Plan for the purpose of redesignating the subject lands, identified on Attachment 1 of this report, from “Rural Policy Area” to “Urban Area”.
2. Regional staff be authorized to appear before the Ontario Municipal Board, in support of the Regional position as outlined in this report on the following matters:
 - Request to amend the Regional Official Plan to redesignate lands shown as “Northern Portion” on the key map from “Rural Policy Area” to “Urban Area” be refused.
 - Application to amend the Town of Aurora’s Official Plan to redesignate lands shown as “Northern Portion” on the key map from “Rural” to “Low-Medium Density” is not supported.

- Application to amend the Town of Aurora's Official Plan to redesignate lands shown as "Southern Portion" on the key map from "Medium/High Density" to "Low-Medium Density" is not supported.
