1. Council authorize the Commissioner of Community and Health Services to approve the distribution of the \$365,000 remaining from the \$2.676 million provincial building repair funding provided in 2008, as grants to housing providers having eligible building repair requirements in accordance with provincial program guidelines.
2. Council authorize the Commissioner of Community and Health Services in consultation with the Commissioner of Finance, to amend the secured loan framework for social housing building repairs as needed to secure the Region's investments in the social housing portfolio in a manner that complies with the eligibility requirements of the provincially administered social housing mortgage pool, subject to prior review by Legal Services.

April 30, 2010, recommending that:

1. Council approve the issuance of a Request for Proposal, based on the framework proposed in this report so the Region may identify potential affordable housing projects to be owned and operated by Housing York Inc. and utilize the York Region Investing in Ontario funding, and/or any future federal and provincial funding earmarked to increase the supply of affordable housing.
2. Council authorize the Regional Chair and Chief Administrative Office to award contract(s) to the successful proponent(s) identified through the Request for Proposal process should an agreement(s) fulfilling the requirements of the Region and Housing York Inc. be reached and provided that the Regional equity required to purchase the project(s) does not exceed the \$35.3 million remaining in York Region Investing in Ontario funding.
3. The Commissioner of Community and Health Services be authorized to recommend successful projects identified through the Request for Proposal process to the Province for funding under the Canada-Ontario Affordable Housing Program Extension that meet the Provincial Program Guidelines and Regional requirements.
4. Staff report back to Council on project progress in early 2011.
