**YRT/Viva Transit U-Pass Program**

1. Staff be authorized to implement a Universal Transit Pass (U-Pass) program with Greater Toronto Area post-secondary institutions, in partnership with the Toronto Transit Commission (TTC) and GO Transit.
2. The U-Pass price for York Region Transit/Viva be established at a rate that is consistent with the TTC and GO Transit.
3. The Regional Chair and Clerk be authorized to execute any contracts with respect to the U-Pass program, subject to the approval of Legal Services as to form and content.

**Stock Transportation Contract Extension**

3. Regional Council authorize an extension to the existing contract with Stock Transportation Limited for the supply of yellow school buses to operate designated conventional transit services during off-peak periods. The extension shall be until September 2, 2008, with the option to extend the contract on a month-to-month basis until December 31, 2008.
4. The terms and conditions of the original contract remain the same for the duration of the contract, including an hourly operating rate of \$30.37, plus GST, for small school buses, \$36.11, plus GST, for large school buses, and a fuel escalation surcharge of \$200 per month.
5. The Regional Chair and Regional Clerk be authorized to execute the contract, subject to the approval of Legal Services as to form and content.
