### THE REGIONAL MUNICIPALITY OF YORK

#### **BYLAW NO. 2018-66**

To acquire certain lands for or in connection with the widening and reconstruction of Rutherford Road (YR 73), City of Vaughan

WHEREAS the Council of The Regional Municipality of York on June 29, 2017, by its adoption of Clause 15 of Report 11 of the Committee of the Whole approved of the expropriation of the lands therein referred to for or in connection with the widening and reconstruction of Rutherford Road (YR 73) from Jane Street (YR 55) to Westburne Drive, in the City of Vaughan, provided that there were no requests for a hearing of necessity; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, c. E.26, as amended (the "Act"); and

WHEREAS requests for a hearing before an Inquiry Officer were received and subsequently withdrawn.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

- 1. The expropriation of the lands referred to in section 2 is hereby approved and the Regional Chair and Regional Clerk are authorized to execute any required documents in accordance with the Act.
