BYLAW NO. 2018-14

A bylaw to implement all-way stop control at intersections under the Region's jurisdiction and to delegate to the Commissioner of Transportation Services the power to implement all-way stop control

WHEREAS section 137(a) of the *Highway Traffic Act*, RSO 1990, (the "Act") as amended, provides that in addition to stop signs required at intersections on through highways, the council of a municipality may by bylaw provide for the erection of stop signs at intersections on highways under its jurisdiction;

AND WHEREAS section 23.1 of the *Municipal Act, 2001*, provides that a municipality may delegate its powers to a person, subject to certain restrictions;

NOW THEREFORE, the Council of The Regional Municipality of York hereby enacts as follows:

- 1. The erection of stop signs, resulting in an all-way stop control, is hereby authorized at each of the intersections set out in the attached Schedule "A".
- 2. The Commissioner of Transportation Services (the "Commissioner") is hereby delegated the authority to authorize the erection of stop signs resulting in an all-way stop control at intersections under the Region's jurisdiction where, in the Commissioner's opinion, all-way stop control is necessary to provide for the orderly movement of traffic.
- 3. The attached Schedule "A" setting out intersections where all-way stop control has been implemented shall form part of this bylaw.
- 4. The Regional Clerk is hereby authorized to amend Schedule "A" to this bylaw from time to time, to reflect a decision made by the Commissioner under Section 2 of this bylaw.
