



# **OMB Background**




No other Province has a tribunal with same extent of jurisdiction

### Theme 1: OMB's Jurisdiction and Powers

- Exempt or limit appeals of OPs approved by Province, or where municipalities are implementing provincial policy
- ✓ Eliminate de novo (as new) hearings
- Send significant new information back to municipal council

#### York Requests:

 Exempt municipally-initiated OPs that conform to Provincial legislation and policies from appeal

#### Limit scope of issues dealt with by the Board

# Theme 2: Citizen Participation and Local Perspective

- ✓ Expand Citizen Liaison Office
- Increase staff, including in-house planning experts and lawyers
- ✓ Funding tools for citizens

#### York Requests:

 User-friendly website with expanded educational materials

# Addressing concerns about public ability to participate in OMB hearings

# Theme 3: Clear and Predictable Decision-making

- Complex hearings to be heard by multi-member panels
- Increase number of OMB members with necessary skills
- ✓ Clearly worded, plain-language decisions

#### York Requests:

- Better compensation for board members
- Performance review for board members
- Standard case book and document book

# Theme 4: Modern Procedures and Faster Decisions

- Less complex and more accessible tribunal procedures
- ✓ Allow active adjudication
- ✓ Flexibility on how evidence is heard
- ✓ More hearings in writing
- ✓ Faster decision timelines
- ✓ Clear rules

# Addressing concern that hearings are too long and complex

### Theme 5: Alternative Dispute Resolution and Fewer Hearings

- ✓ Promote mediation
- ✓ Require appeals to first be considered by a mediator
- ✓ Stronger case management

#### York Requests:

- Review and update fee structure
- Case management to reduce duplication of evidence
- Update OMB rules of practice and procedure

#### Encouraging more use of mediation
