#### THE REGIONAL MUNICIPALITY OF YORK [DEBENTURE COMMITTEE]

#### **BYLAW NO. 2016-65**

To authorize the borrowing upon sinking fund debentures in the principal amount of \$150,000,000.00 (\$60,000,000.00 of which amount may be raised by the issue of refinancing sinking fund debentures on or before the maturity date) for capital works of The Regional Municipality of York

(Re-opening of the 2.50% \$150,000,000.00 sinking fund debentures due June 2, 2026 issued on June 2, 2016)

**WHEREAS** the *Municipal Act*, 2001, as amended (the "Act") provides that a municipality may incur a debt for municipal purposes, whether by borrowing money or in any other way, and may issue debentures and prescribed financial instruments and enter prescribed financial agreements for or in relation to the debt;

**AND WHEREAS** on September 23, 2010 the Council of The Regional Municipality of York (the "**Upper-tier Municipality**") by By-law No. 2010-69 established a Debenture Committee and delegated to the Debenture Committee, among other things, the authority to enact by-laws authorizing the issuance of debentures in accordance with the debt authority previously provided by Regional Council and the Region's Capital Financing and Debt Policy, as amended (the "**Policy**");

**AND WHEREAS** the Act also provides that all debentures issued under a by-law passed by a regional municipality for its own purposes are direct, joint and several obligations of the regional municipality and its lower-tier municipalities;

**AND WHEREAS** subsection 408(4)(a) of the Act provides that a debenture by-law shall provide for raising in each year as part of the general upper-tier levy the amounts of principal and interest payable in each year under the by-law to the extent that the amounts have not been provided for by other taxes or by fees or charges imposed on persons or property by a by-law of any municipality and subsections 408(4)(b) and (c) provide that a debenture by-law shall include provisions that contemplate the payment of principal and interest in each year. Subsection 408(5) of the Act further provides that the total amount of principal and interest that must be raised in a year under subsection 408(4)(a) of the Act does not include any outstanding amount of principal specified as payable on the maturity date of a debenture if one or more refinancing debentures are issued by the municipality on or before the maturity date in respect of the outstanding principal; **AND WHEREAS** Subsection 409(1)(a) of the Act provides that a municipality may provide in a debenture by-law that all or a portion of the debentures are sinking fund debentures which have the principal payable on a fixed date and subsection 409(2) of the Act provides that a by-law passed under section 409 of the Act shall provide for an estimated amount in each year for the sinking fund which, with interest compounded annually, will be sufficient to pay the principal of the debentures at maturity. Subsection 409(3) of the Act provides that an amount required to be provided in a year under subsection 409(2) of the Act shall be deemed to be an amount of principal payable to the lender in the year for the purposes of subsection 408(4)(a) of the Act (as well as of other subsections of the Act);

**AND WHEREAS** subsection 408(2.1) of the Act provides that a municipality may issue a debenture or other financial instrument for long-term borrowing only to provide financing for a capital work;

**AND WHEREAS** the Council of the Upper-tier Municipality has authorized the undertaking of the capital works of the Upper-tier Municipality (individually a "**Capital Work**", collectively the "**Capital Works**") set out in Column (2) of Schedule "A" attached hereto and forming part of this by-law ("**Schedule** "A"") and desires to issue debentures for each of the Capital Works in the respective principal amount specified in Column (5) of Schedule "A". All of the authorizations in respect of the Capital Works have been granted in accordance with the Policy, the Act and the applicable regulations;

**AND WHEREAS** before authorizing the Capital Works, all of which Capital Works were authorized after June 24, 2011, the date on which Ontario Regulation 403/02 was amended by Ontario Regulation 289/11 (the "**Regulation**") and before authorizing any additional cost amount and any additional debenture authority in respect thereof, the Council of the Upper-tier Municipality had its Commissioner of Finance and Treasurer calculate an updated growth-related debt and financial obligation limit in accordance with the Regulation and, prior to the Council of the Upper-tier Municipality authorizing each such Capital Work, each such additional cost amount and each such additional debenture authority, the Commissioner of Finance and Treasurer determined that the estimated annual amount payable in respect of each such Capital Work, each such additional debenture authority, would not cause the Upper-tier Municipality to exceed its updated growth-related debt and financial obligation limit and that the approval of each such Capital Work, each such additional debenture authority by the Ontario Municipal Board pursuant to the Regulation was not required;

**AND WHEREAS** on June 2, 2016 the Upper-tier Municipality issued 10 year sinking fund debentures of the Upper-tier Municipality in the principal amount of \$150,000,000.00 pursuant to debenture Bylaw No. 2016-38 (the "Original Debentures") for the capital works of the Upper-tier Municipality described therein (the "Original Issue");

**AND WHEREAS** Bylaw No. 2016-38 provides that the Upper-tier Municipality reserves the right to issue additional sinking fund debentures of the same maturity, interest rate and terms and conditions;

**AND WHEREAS** to provide long-term financing for the Capital Works it is now deemed to be expedient re-open the Original Issue and to borrow money by the issue and sale of additional sinking fund debentures of the Upper-tier Municipality in the principal amount of \$150,000,000.00 (\$60,000,000.00 of which amount may be raised by the issue of refinancing sinking fund debentures on or before the maturity date), such additional sinking fund debentures forming part of one series of additional sinking fund debentures in the aggregate principal amount of \$150,000,000.00 to be issued on October 4, 2016, all such additional sinking fund debentures collectively forming part of one aggregate series of sinking fund debentures with the Original Debentures in the aggregate principal amount of \$300,000,000.00 (\$120,000,000.00 of which amount may be raised by the issue of refinancing sinking fund debentures in respect of the Debentures on or before the maturity date) with the same maturity, interest rate and terms and conditions as the Original Debentures, and all such additional sinking fund debentures are to be payable at the time and bearing interest as hereinafter set forth, as agreed to by the Upper-tier Municipality on September 22, 2016;

**NOW THEREFORE** the Debenture Committee of The Regional Municipality of York hereby enacts as follows:

- 1. For the Capital Works, the borrowing upon the credit of the Upper-tier Municipality at large of the principal amount of \$150,000,000.00 (\$60,000,000.00 of which amount may be raised by the issue of refinancing sinking fund debentures on or before the maturity date) and the issue of additional sinking fund debentures therefor forming part of one series of additional sinking fund debentures in the aggregate principal amount of \$150,000,000.00 (\$60,000,000.00 of which amount may be raised by the issue of refinancing sinking fund debentures on or before the maturity, interest rate and terms and conditions as the Original Debentures, in minimum denominations of \$1,000.00, as hereinafter set forth, are hereby authorized on the basis that the additional sinking fund debentures shall, when combined with the Original Debentures, constitute one series of 10 year sinking fund debentures in the aggregate principal amount of \$300,000,000.00.
- 2. The Regional Chair and the Commissioner of Finance and Treasurer of the Uppertier Municipality are hereby authorized to cause any number of additional sinking fund debentures in the principal amount of \$150,000,000.00 (\$60,000,000.00 of which amount may be raised by the issue of refinancing debentures on or before the maturity date), as described in section 1 above, (the "Debentures") payable as to principal on June 2, 2026 with the first interest payment payable on December 2, 2016 and semi-annual instalments of interest payable thereafter on each of June 2 and December 2 to be issued for such amounts of money as may be required for the Capital Works in global and definitive forms, not exceeding in total the said principal amount of \$150,000,000.00. The Debentures shall bear the Upper-tier Municipality's municipal seal and the signatures of the Regional Chair and of the Commissioner of Finance and Treasurer of the Upper-tier Municipality, all in accordance with the provisions of the Act. The municipal seal of the Upper-tier Municipality and the signatures referred to in this section may be printed, lithographed, engraved or otherwise mechanically reproduced. The Debentures are sufficiently signed if they bear the required signatures and each person signing has the authority to do so on the date he or she signs. The Debentures shall initially be

issued in global fully registered form as three certificates, each in the principal amount of \$50,000,000.00 (in the aggregate principal amount of \$150,000,000.00), each substantially in the form attached as Schedule "B" hereto and forming part of this by-law (the "**Global Debentures**"). The Global Debentures shall initially be issued in the name of CDS & CO. as nominee of CDS Clearing and Depository Services Inc. ("**CDS**"), and each shall provide for payment of principal and interest electronically in final and irrevocable same-day funds in accordance with the applicable requirements of CDS, so long as the Global Debentures are held by CDS.

3. (1)The Debentures shall all be dated the 4th day of October, 2016, and as to both principal and interest shall be expressed and be payable in lawful money of Canada. The Debentures shall be issued for a term of approximately 10 years bearing interest at the rate of 2.50% per annum and shall be payable as follows: the principal payment at maturity will be made on June 2, 2026, the first interest payment (accrued from June 2, 2016) in the amount of \$1,875,000.00 will be made on December 2, 2016 and thereafter interest payments in the aggregate amount of \$3,750,000.00 will be made in each year of the currency of the Debentures in semiannual instalments of \$1,875,000.00 on each of June 2 and December 2 (commencing on June 2, 2017). The additional amount of \$8,370,849.54 shall be deposited in each year of the said period on or before June 2 (commencing on June 2, 2017) by the Commissioner of Finance and Treasurer of the Upper-tier Municipality, or an authorized official of the Upper-tier Municipality, into the sinking fund established under Bylaw No. 2016-38 in respect of the Original Issue (the "Sinking Fund"), which amount, with interest compounded annually, will be sufficient to pay at maturity (June 2, 2026) the principal of the Debentures and, with the annual contribution described in Bylaw No. 2016-38, will be sufficient to pay the principal of the Original Debentures, subject to the ability of the Upper-tier Municipality to issue refinancing sinking fund debentures in respect of the Debentures for a further term of up to 10 years, or such longer term as may subsequently be authorized by the Council of the Upper-tier Municipality, in accordance with the Act. The annual contribution to the Sinking Fund in respect of the Debentures takes into account the Upper-tier Municipality's ability to issue refinancing sinking fund debentures in respect of the outstanding principal of the Debentures in accordance with the provisions of this by-law and the Act.

(2) Of the principal amount of \$150,000,000.00 that matures in respect of the Debentures on June 2, 2026, the principal amount of \$60,000,000.00 payable thereunder may be raised by the issue of refinancing sinking fund debentures over a further period not to exceed 10 years (20 years being the maximum period of years for the repayment of the debt for which the Debentures will be and the refinancing debentures may be issued), as set out in Section B(6) to the Policy unless the Council of the Upper-tier Municipality or the Debenture Committee, as the case may be, has otherwise specifically approved a different maximum term of years for any of such Capital Works, or such longer term up to 12 months that may have been determined by the Commissioner of Finance and Treasurer and/or Director, Treasury Office where there has been a perceived benefit to do so based on the prevailing financial market conditions.

(3) Payments in respect of contributions to the Sinking Fund as well as principal of and interest on the Debentures shall be made only on a day on which banking institutions in Toronto, Ontario, are not authorized or obligated by law or executive order to be closed (a "**Business Day**") and if any date for payment is not a Business Day, payment shall be made on the next following Business Day and no further interest shall be paid in respect of the delay in such payment.

- 4. Interest shall be payable to the date of maturity of the Debentures and on default shall be payable both before and after default and judgment. Any amounts payable by the Upper-tier Municipality as interest on overdue principal or interest in respect of the Debentures shall be paid out of current revenue. Whenever it is necessary to compute any amount of interest in respect of the Debentures for a period of less than one full year, other than with respect to regular interest payments, such interest shall be calculated on the basis of the actual number of days in the period and a year of 365 days or 366 days, if applicable.
- 5. In limited circumstances (as agreed to by both the Upper-tier Municipality and CDS) the Global Debentures shall be exchangeable for certificated Debentures in definitive fully registered form in authorized denominations upon surrender of the Global Debentures to the Commissioner of Finance and Treasurer of the Upper-tier Municipality. Any of the Debentures issued as definitive Debentures may, with the approval of the Debenture Committee, be countersigned in writing by officials so designated by the Debenture Committee. The definitive Debentures shall aggregate the same principal amount as the principal outstanding balance of the Global Debentures as of the record date for such exchange in accordance with the provisions of the Global Debentures, shall bear the same interest rate and maturity date, shall bear all unmatured interest obligations and shall have the same benefits and be subject to the same terms and conditions as the Global Debentures (except insofar as they specifically relate to the Global Debentures). In issuing definitive Debentures no change shall be made in the amount which would otherwise be payable in each year under the Global Debentures. The definitive Debentures shall be in fully registered form, payable as to principal and outstanding interest in lawful money of Canada at maturity upon presentation and surrender thereof at any specified branch in Canada of the Upper-tier Municipality's bank designated in the definitive Debentures. Prior to maturity, the definitive Debentures shall be payable as to interest by cheque sent by mail to the registered addresses of the registered holders or, if authorized in writing, by electronic transfer.
- 6. (1) In respect of the Debentures, there shall be raised in each year during the currency of the Debentures as part of the general upper-tier levy as follows: the first interest payment (accrued from June 2, 2016) in the amount of \$1,875,000.00 will be made on December 2, 2016 and thereafter interest payments in the aggregate amount of \$3,750,000.00 will be made in each year of the currency of the Debentures in semi-annual instalments of \$1,875,000.00 on each of June 2 and December 2 (commencing on June 2, 2017). There shall also be raised in each year during the said period as part of the general upper-tier levy, the additional amount of \$8,370,849.54 for deposit into the Sinking Fund on or before June 2 (commencing on June 2, 2017) for the payment at maturity (June 2, 2026) of the principal of the Debentures, subject to the ability of the Upper-tier Municipality to issue refinancing

sinking fund debentures for a further term of up to 10 years, in accordance with the Act. In each such year, for the Capital Works, the said two amounts (the amount for interest and the amount for the contribution to the Sinking Fund) shall be raised as part of the general upper-tier levy to the extent that the amounts have not been provided for by any other available source including other taxes or fees or charges imposed on persons or property by a by-law of any municipality. The total amount payable for deposit into the Sinking Fund and interest that must be raised in each such year does not include any amount payable for deposit into the Sinking Fund for the refinancing debentures that the Upper-tier Municipality is authorized to issue in respect of the Debentures on or before the maturity date of the Debentures, in accordance with the provisions of this by-law and the Act.

The lower-tier municipalities that comprise the Upper-tier Municipality (2)"Lower-tier Municipality", collectively the "Lower-tier (individually а Municipalities") shall pay to the Upper-tier Municipality, as part of the general upper-tier levy the amounts required to be paid to the Upper-tier Municipality by the Lower-tier Municipalities in respect of the Capital Works, in accordance with the manner in which the general upper-tier levy is required, from time to time, to be paid to the Upper-tier Municipality. Such amounts constitute debt of the Lower-tier Municipalities to the Upper-tier Municipality and such amounts shall, when combined with any amount payable by the Upper-tier Municipality in the year for repayment of the debt for which the Debentures are to be issued, be sufficient to meet the total amount payable for deposit into the Sinking Fund and interest payable in the year by the Upper-tier Municipality in respect of the Debentures, all in accordance with the provisions of this by-law and the Act.

(3) If any Lower-tier Municipality fails to make any payment or portion of it as provided in this by-law, such Lower-tier Municipality shall pay interest to the Upper-tier Municipality on the amount in default at the rate of 15% per annum, from the date the payment is due until it is made.

(4) There shall be raised, pursuant to this by-law, in each year of the currency of the Debentures, as part of the general upper-tier levy, the amounts required to be paid to the Upper-tier Municipality in any previous year by any one or more of the Lower-tier Municipalities to the extent that the amounts have not been paid to the Upper-tier Municipality in accordance with this by-law and the Act.

- 7. The Debentures may contain any provision for their registration thereof authorized by any statute relating to municipal debentures in force at the time of the issue thereof.
- 8. The Upper-tier Municipality shall maintain a registry in respect of the Debentures in which shall be recorded the names and the addresses of the registered holders and particulars of the Debentures held by them respectively and in which particulars of the cancellations, exchanges, substitutions and transfers of Debentures may be recorded and the Upper-tier Municipality is authorized to use electronic, magnetic or other media for records of or related to the Debentures or for copies of them.

- 9. The Upper-tier Municipality shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Upper-tier Municipality shall deem and treat registered holders of the Debentures, including the Global Debentures, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Upper-tier Municipality on the Debentures to the extent of the amount or amounts so paid. Where a Debenture is registered in more than one name, the principal of and interest from time to time payable on such Debenture shall be paid to or to the order of all the joint registered holders thereof, failing written instructions to the contrary from all such joint registered holders, and such payment shall constitute a valid discharge to the Uppertier Municipality. In the case of the death of one or more joint registered holders, despite the foregoing provisions of this section, the principal of and interest on any Debentures registered in their names may be paid to the survivor or survivors of such holders and such payment shall constitute a valid discharge to the Upper-tier Municipality.
- 10. The Debentures are transferable or exchangeable at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality upon presentation for such purpose accompanied by an instrument of transfer or exchange in a form approved by the Upper-tier Municipality and which form is in accordance with the prevailing Canadian transfer legislation and practices, executed by the registered holder thereof or such holder's duly authorized attorney or legal personal representative, whereupon and upon registration of such transfer or exchange and cancellation of the Debenture or Debentures presented, the Regional Chair and the Commissioner of Finance and Treasurer shall issue and deliver a new Debenture or Debentures of an equal aggregate principal amount in any authorized denomination or denominations as directed by the transferor, in the case of a transfer or as directed by the registered holder in the case of an exchange.
- 11. The Regional Chair and the Commissioner of Finance and Treasurer shall issue and deliver new Debentures in exchange or substitution for Debentures outstanding on the registry with the same maturity date and of like form which have become mutilated, defaced, lost, subject to a mysterious or unexplainable disappearance, stolen, destroyed or dematerialized, provided that the applicant therefor shall have: (a) paid such costs as may have been incurred in connection therewith; (b) (in the case when a Debenture is mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized) furnished the Upper-tier Municipality with such evidence (including evidence as to the certificate number of the Debenture in question) and indemnity in respect thereof satisfactory to the Upper-tier Municipality any mutilated or defaced Debenture in respect of which new Debentures are to be issued in substitution.
- 12. The Debentures issued upon any registration of transfer or exchange or in substitution for any Debentures or part thereof shall carry all the rights to interest if any, accrued and unpaid which were carried by such Debentures or part thereof and shall be so dated and shall bear the same maturity date and, subject to the provisions

of this by-law, shall be subject to the same terms and conditions as the Debentures in respect of which the transfer, exchange or substitution is effected.

- 13. The cost of all transfers and exchanges, including the printing of authorized denominations of the new Debentures, shall be borne by the Upper-tier Municipality. When any of the Debentures are surrendered for transfer or exchange the Commissioner of Finance and Treasurer of the Upper-tier Municipality shall: (a) in the case of an exchange, cancel and destroy the Debentures surrendered for exchange; (b) in the case of an exchange, certify the cancellation and destruction in the registry; (c) enter in the registry particulars of the new Debenture or Debentures issued in exchange; and (d) in the case of a transfer, enter in the registry the name of the registered holder as directed by the transferor.
- 14. Subject to an agreement that the Upper-tier Municipality may enter into to the contrary, reasonable fees may be imposed by the Upper-tier Municipality for the substitution of a new Debenture or new Debentures for any of the Debentures that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized and for the replacement of any of the interest cheques that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen or destroyed. When new Debentures are issued in substitution in these circumstances the Upper-tier Municipality shall: (a) treat as cancelled and destroyed the Debentures in respect of which new Debentures will be issued in substitution; (b) certify the deemed cancellation and destruction in the registry; (c) enter in the registry particulars of the new Debentures issued in substitution; and (d) make a notation of any indemnities provided.
- 15. Except as otherwise expressly provided herein, any notice required to be given to a registered holder of one or more of the Debentures will be sufficiently given if a copy of such notice is mailed or otherwise delivered to the registered address of such registered holder.
- 16. (1) The execution of a purchase letter in respect of the Debentures, dated as at September 22, 2016, by the Director, Treasury Office is hereby ratified, confirmed and approved, the Regional Chair and the Commissioner of Finance and Treasurer are hereby authorized to cause the Debentures to be issued, one or more of the Commissioner of Finance and Treasurer and the Regional Clerk are hereby authorized to generally do all things and to execute all other documents and papers in the name of the Upper-tier Municipality in order to carry out the sale of the Debentures through CDS's book entry only system and the Commissioner of Finance and Treasurer is authorized to affix the Upper-tier Municipality's municipal seal to any of such documents and papers.

(2) The money received by the Upper-tier Municipality from the sale of the Debentures, including any premium, and any earnings derived from the investment of that money, after providing for the expenses related to their issue, if any, shall be apportioned and applied to the Capital Works, and to no other purpose except as permitted by the Act.

- 17. The Upper-tier Municipality reserves the right to issue additional sinking fund debentures of the same maturity, interest rate and terms and conditions.
- 18. Subject to the Upper-tier Municipality's investment policies and goals and the applicable legislation, the Upper-tier Municipality may, if not in default under the Debentures, at any time purchase any of the Debentures in the open market or by tender or by private contract at any price and on such terms and conditions (including, without limitation, the manner by which any tender offer may be communicated or accepted and the persons to whom it may be addressed) as the Upper-tier Municipality may in its discretion determine.

The Global Debentures are enforceable against the Issuer and the Lower-tier Municipalities subject to the special jurisdiction and powers of the Ontario Municipal Board over defaulting municipalities under the *Municipal Affairs Act*, as amended. This opinion is subject to and incorporates all the assumptions, qualifications and limitations set out in our opinion letter delivered on the date of the Global Debentures.

## **CONDITIONS OF GLOBAL DEBENTURE**

### Form, Denomination, Ranking and Beneficial Interests in Global Debenture

- 1. The additional sinking fund debentures issued pursuant to the Debenture By-law (individually a "**Debenture**" and collectively the "**Debentures**") are issuable as fully registered Debentures without coupons in minimum denominations of \$1,000.00.
- 2. The Debentures are direct, general, unsubordinated, joint and several obligations of the Issuer and of the Lower-tier Municipalities. The Debentures rank concurrently and equally in respect of payment of principal and interest with all other debentures of the Issuer except for the availability of money in a sinking or retirement fund for a particular issue of debentures, including the sinking fund established in respect of the Debentures. - 3. This Debenture is a Global Debenture registered in the name of the nominee of CDS and held by CDS. Beneficial interests in this Global Debenture are represented through book entry accounts, to be established and maintained by CDS, on its records for CDS's participants (the "Participants") in accordance with its participant agreement and rules and procedures which are posted on CDS's website.
- 4. Except in the limited circumstances described herein, owners of beneficial interests in this Global Debenture will not be entitled to have Debentures registered in their names, will not receive or be entitled to receive physical delivery of Debentures and will not be considered registered holders of Debentures under the Conditions. The Issuer does not have any responsibility or liability for maintaining, supervising or reviewing any records of CDS or Participants relating to payments made or to be made by CDS or any Participant on account of beneficial ownership interests in this Global Debenture.

## **Certificated Debentures**

- 5. 9. The Issuer shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Issuer shall deem and treat registered holders of Debentures, including this Global Debenture, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Issuer on the Debentures to the extent of the amount or amounts so paid.

## **Payments of Principal and Interest**

10. In each year during the currency of the Debentures, interest shall be payable as follows: the first interest payment in the amount of \$1,875,000.00 will be made on December 2, 2016 and thereafter interest payments in the aggregate amount of \$3,750,000.00 will be made in each year of the currency of the Debentures in semi-annual instalments (\$1,875,000.00 on each of June 2 and December 2). The additional amount of \$8,370,849.54 shall be deposited on or before June 2 (commencing on June 2, 2017) by the Issuer into the sinking fund previously established under Bylaw No. 2016-38 for the payment of the principal of the Debentures at maturity (the "Sinking Fund"), subject to the ability of the Issuer to

issue refinancing sinking fund debentures, all in accordance with the provisions of the *Municipal Act*, 2001, as amended.

- 11. The record date for purposes of payment of a deposit into the Sinking Fund and of payment of principal and of interest on the Debentures is as of 5:00 p.m. on the thirtieth calendar day preceding any relevant Payment Date, including the maturity date. Principal of and interest on the Debentures are payable by the Issuer to the persons registered as holders in the registry on the relevant record date. The Issuer shall not be required to register any transfer, exchange or substitution of Debentures during the period from any record date to the corresponding Payment Date.
- 12. The Issuer shall make all payments in respect of semi-annual interest on the Debentures on the Payment Dates commencing on December 2, 2016 and of principal at maturity, electronically in final and irrevocable same-day funds in accordance with the applicable requirements of CDS, so long as this Global Debenture is held by CDS.
- 13. In the case that certificated Debentures in definitive form are issued, the Issuer shall make all payments in respect of principal and outstanding interest in lawful money of Canada at maturity upon presentation and surrender thereof at any specified branch in Canada of the Issuer's bank designated in the definitive Debentures, and prior to maturity, shall make payments of interest, by cheque sent by mail to the registered addresses of the registered holders or, if authorized in writing, by electronic transfer.
- 14. Whenever it is necessary to compute any amount of interest in respect of the Debentures for a period of less than one full year, other than with respect to regular semi-annual interest payments, such interest shall be calculated on the basis of the actual number of days in the period and a year of 365 days or 366 days, if applicable.
- 15. Payments in respect of contributions to the Sinking Fund as well as principal of and interest on the Debentures shall be made only on a day on which banking institutions in Toronto, Ontario, are not authorized or obligated by law or executive order to be closed (a "**Business Day**") and if any date for payment is not a Business Day, payment shall be made on the next following Business Day and no further interest shall be paid in respect of the delay in such payment.
- 16. Where a Debenture is registered in more than one name, the principal of and interest from time to time payable on such Debenture shall be paid to or to the order of all the joint registered holders thereof, failing written instructions to the contrary from all such joint registered holders, and such payment shall constitute a valid discharge to the Issuer.
- 17. In the case of the death of one or more joint registered holders, despite sections 9 and 16 of the Conditions, the principal of and interest on any Debentures registered in their names may be paid to the survivor or survivors of such holders and such payment shall constitute a valid discharge to the Issuer.

## **Transfers, Exchanges and Substitutions**

18. Debentures are transferable or exchangeable at the office of the Commissioner of Finance and Treasurer of the Issuer upon presentation for such purpose accompanied by an instrument of transfer or exchange in a form approved by the Issuer and which

form is in accordance with the prevailing Canadian transfer legislation and practices, executed by the registered holder thereof or such holder's duly authorized attorney or legal personal representative, whereupon and upon registration of such transfer or exchange and cancellation of the Debenture or Debentures presented, a new Debenture or Debentures of an equal aggregate principal amount in any authorized denomination or denominations will be delivered as directed by the transferor, in the case of a transfer or as directed by the registered holder in the case of an exchange.

- 19. The Issuer shall issue and deliver Debentures in exchange for or in substitution for Debentures outstanding on the registry with the same maturity date and of like form in the event of a mutilation, defacement, loss, mysterious or unexplainable disappearance, theft, destruction or dematerialization, provided that the applicant therefor shall have: (i) paid such costs as may have been incurred in connection therewith; (ii) (in the case of a lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized Debenture) furnished the Issuer with such evidence (including evidence as to the certificate number of the Debenture in question) and indemnity in respect thereof satisfactory to the Issuer in its discretion; and (iii) surrendered to the Issuer any mutilated or defaced Debenture in respect of which new Debentures are to be issued in substitution.
- 20. Each Debenture executed and delivered upon any registration of transfer or exchange for or in substitution for any Debenture or part thereof shall carry all the rights to interest, if any, accrued and unpaid which were carried by such Debenture or part thereof and shall be so dated.
- 21. Subject to an agreement that the Issuer may enter into to the contrary, the Issuer shall not impose any fees in respect of the Debentures, in the normal course of business, other than reasonable fees for the issue of new Debentures or for the issue of new cheques in substitution for Debentures that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen, destroyed or dematerialized, or interest cheques that are mutilated, defaced, lost, mysteriously or unexplainably missing, stolen or destroyed.

## **Purchases**

22. Subject to the investment policies and goals of the Issuer and the applicable legislation, the Issuer may, if not in default under the Debentures, at any time purchase Debentures in the open market or by tender or by private contract at any price and on such terms and conditions (including without limitation, the manner by which any tender offer may be communicated or accepted and the persons to whom it may be addressed) as the Issuer may in its discretion determine.

## **Additional Debentures**

23. The Issuer has reserved the right to issue additional sinking fund debentures of the same maturity, interest rate and terms and conditions.

## **Notices**

24. Except as otherwise expressly provided herein, any notice required to be given to a registered holder of one or more of the Debentures will be sufficiently given if a copy of such notice is mailed or otherwise delivered to the registered address of such registered holder. If the Issuer or any registered holder is required to give any notice in connection with the Debentures on or before any day and that day is not a Business Day then such notice may be given on the next following Business Day.

## <u>Time</u>

25. Unless otherwise expressly provided herein, any reference herein to a time shall be considered to be a reference to Toronto time.

## **Governing Law**

26. The Debentures are governed by and shall be construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable in Ontario.
