BYLAW NO. 2015-50

To acquire certain lands for or in connection with the widening and reconstruction of Major Mackenzie Drive West (YR 25), in the City of Vaughan

WHEREAS the Council of The Regional Municipality of York on May 21, 2015, by its adoption of Clause 15 of Report 10 of the Committee of the Whole authorized an application for approval to expropriate the lands therein referred to for or in connection with the widening and reconstruction of Major Mackenzie Drive West (YR 25) from Islington Avenue (YR 17) to approximately 500 metres west of the Canadian Pacific Railway crossing, in the City of Vaughan; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, c. E.26, as amended (the "Act"); and

WHEREAS no notification of a desire for a hearing has been received and the time for giving such notification has expired; and

WHEREAS the Council of The Regional Municipality of York on September 24, 2015, by its adoption of Clause 13 of Report 14 of the Committee of the Whole approved the expropriation of the hereinafter described lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the lands referred to in section 3 is hereby approved for or in connection with the widening and reconstruction of Major Mackenzie

Drive West (YR 25) from Islington Avenue (YR 17) to approximately 500 metres west of the Canadian Pacific Railway crossing, in the City of Vaughan.

2. The Regional Chair and Regional Clerk are hereby authorized and directed to execute a Certificate of Approval pursuant to the Act.

3. The Region, as expropriating authority, expropriate the following lands by the preparation, execution and registration of a plan of expropriation:

Fee Simple Interest: Part 1 on Plan 65R-35522 Parts 1, 2 and 3 on Plan 65R-35524 Part 1 on Plan 65R-35527 Parts 1 to 8, both inclusive, on Plan 65R-35528 Parts 4, 5 and 6 on Plan 65R-35530 Parts 3 to 13, both inclusive, on Plan 65R-35531 Parts 1 to 18, both inclusive, on Plan 65R-35532 Parts 2, 3, 13, 14 and 15 on Plan 65R-35564 <u>Temporary Easement Interest</u>: Parts 1 and 3 on Plan 65R-35530 Part 2 on Plan 65R-35531 Parts 1 and 12 on Plan 65R-35564 (commencing on May 1, 2016 and expiring on December 31, 2020)

4. The Commissioner of Corporate Services is authorized to cause the said plan or plans to be registered in the proper Land Registry Office, to give notice of such expropriation in accordance with the Act and to execute all necessary documents to effect the transaction.
