BYLAW NO. 2015-39

To acquire certain lands for or in connection with the widening and reconstruction of Bathurst Street (YR 38), in the City of Vaughan and Town of Richmond Hill

WHEREAS the Council of The Regional Municipality of York on September 11, 2014, by its adoption of Clause 36 of Report 13 of the Committee of the Whole authorized an application for approval to expropriate the lands therein referred to for or in connection with the widening and reconstruction of Bathurst Street (YR 38) from Highway 7 (YR 7) to Teston Road (YR 49) / Elgin Mills Road West (YR 49), in the City of Vaughan and Town of Richmond Hill; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, c. E.26, as amended (the "Act"); and

WHEREAS no notification of a desire for a hearing has been received and the time for giving such notification has expired; and

WHEREAS the Council of The Regional Municipality of York on June 25, 2015, by its adoption of Clause 18 of Report 12 of the Committee of the Whole approved the expropriation of the hereinafter described lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

 The expropriation of the lands referred to in section 3 is hereby approved for or in connection with the widening and reconstruction of Bathurst Street (YR 38) from Highway 7 (YR 7) to Teston Road (YR 49) / Elgin Mills Road West (YR 49) in the City of Vaughan and Town of Richmond Hill.

2. The Regional Chair and Regional Clerk are hereby authorized and directed to execute a Certificate of Approval pursuant to the Act.

3. The Region, as expropriating authority, expropriate the following lands by the preparation, execution and registration of a plan of expropriation:
