#### Recommendations

It is recommended that:

1. The York Region Rapid Transit Corporation (YRRTC) Board of Directors endorse the 2015 Metrolinx Multi-Year Capital Expenditures Budget of \$1.04 billion for YRRTC

#### Purpose

 The purpose of this report is to seek the Board's endorsement of the 2015 Metrolinx Multi-Year Capital Expenditures Budget for YRRTC, as submitted to Metrolinx in October 2014

#### Background

#### The total funded Capital Programs for YRRTC is valued at \$3.2 billion

- The YRRTC Funded Capital Programs Expenditures (see Table 1) is being brought forward in two parts:
  - Part One, which is the subject of a separate report on this agenda, seeks the necessary approvals of Regional Council related to the 2015 Regional Multi-Year Capital & Operating Expenditures Budget, which include York Region funded dollars
  - Part Two, which is the subject of this report, seeks the endorsement of the YRRTC Board of Directors related to the 2015 Metrolinx Multi-Year Capital Expenditures Budget, which are 100% Metrolinx funded dollars

- The Regional Capital Program of \$1.4 billion for YRRTC is driven by the shared funding agreements, which York Region entered into with the Provincial and/or Federal governments. York Region's contribution is approximately one-third or \$444.3 million, mainly for the Toronto-York Spadina Subway Extension which starts from the existing Downsview station and will end at the Vaughan Metropolitan Centre
- The Metrolinx Capital Program in April 2011, York Region entered into a Master Agreement with Metrolinx to construct approximately 35 km of dedicated median bus rapidways for a total value of \$1.755 billion, bringing the total Capital Program – when including design and preliminary engineering – to \$1.8 billion

YRRTC is building the rapidways as the project manager for Metrolinx. On completion, asset ownership will transfer to Metrolinx and York Region will become responsible for maintaining and operating the assets

# The 2015 Metrolinx Multi-Year Capital Expenditures Budget, i.e. Capital Spending Authority is \$1.04 billion, of which \$224.6 million will be spent in 2015



# Metrolinx Capital Program, 2015 Metrolinx Multi-Year Capital Expenditures Budget



YRRTC Board Meeting January 15, 2015

- The 2015 Metrolinx Multi-Year Capital Expenditures Budget of \$1.04 billion is exhausted by the Year 2021 and key projects are as follows:
  - Highway 7 East from Highway 404 to Warden Avenue (H3) with all of the 6.0 km of rapidway in service this past December, minor works such as utility relocations and asphalting from South Town Centre to Warden Avenue are planned to bring the rapidway to final project completion by this summer
  - Davis Drive from Yonge Street to Highway 404 (D1) with over 70% of the project completed last year, construction will be on-going with 2.6 km of rapidway in service by end of this December
  - Highway 7 West, Vaughan Metropolitan Centre (H2-VMC) the rapidway is 3.6 km from east of Highway 400 to east of Bowes Road. Construction is underway and the rapidway, east side of Jane St. is projected to be available by Summer 2016 and the remaining west side of Jane St. will be timed to be in service with the opening of the Toronto-York Spadina Subway extension
  - Yonge Street, Richmond Hill Centre to Major Mackenzie Drive (Y2.1); Levendale Road to 19<sup>th</sup> Avenue / Gamble Road (Y2.2); and Mulock Drive to Davis Drive (Y3.2) – the combined rapidway is 8.9 km and projected to be in service by December 2018. Final design will be completed by Q1-2015, with utility relocations and construction to start shortly after
  - Remaining of Highway 7 West, Richmond Hill Centre to Pine Valley Drive (H2); and Enterprise Drive from Birchmount Road to just east side of Kennedy Road (H3.4) – the combined rapidway is 13.6 km and projected to be in service by December 2019. The key activity in 2015 will be the Design-Build-Finance contract award by Summer 2015

# **Financial Implications**

# The 2015 Metrolinx Multi-Year Capital Expenditures Budget of \$1.04 billion is fully funded by Metrolinx

- York Region does not "cash-flow" any of the capital expenditures for the \$1.8 billion program as Metrolinx advances the cash requirements on a quarterly basis
- Approval from Metrolinx for the 2015 Multi-Year Capital Expenditures Budget is already in place with the execution of the Master Agreement in April 2011 and as per the annual cash flow budget submission to Metrolinx in October 2014

### Conclusion

 This report seeks the endorsement of the Board of Directors for the 2015 Metrolinx Multi-Year Capital Expenditures Budget for YRRTC.
