BYLAW NO. 2015-5

To acquire certain lands for or in connection with the widening and reconstruction of Yonge Street (YR 1) from Major Mackenzie Drive (YR 25) to Gamble Road/19th Avenue (YR 29)

Town of Richmond Hill

WHEREAS the Council of The Regional Municipality of York on April 17, 2014, by its adoption of Clause 10 of Report 8 of the Committee of the Whole and on September 11, 2014, by its adoption of Clause 54 of Report 13 of the Committee of the Whole authorized applications for approval to expropriate the lands therein referred to for or in connection with the widening and reconstruction of Yonge Street (YR 1) from Major Mackenzie Drive (YR 25) to Gamble Road/19th Avenue (YR 29), in the Town of Richmond Hill; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, c. E.26, as amended (the "Act"); and

WHEREAS requests for a hearing before an Inquiry Officer were received and subsequently withdrawn; and

WHEREAS the Council of The Regional Municipality of York on January 22, 2015, by its adoption of Clause 13 of Report 2 of the Committee of the Whole approved the expropriation of the hereinafter described lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

- 1. The expropriation of the lands referred to in section 3 is hereby approved for or in connection with the widening and reconstruction of Yonge Street (YR 1) from Major Mackenzie Drive (YR 25) to Gamble Road/19th Avenue (YR 29), in the Town of Richmond Hill.
- 2. The Regional Chair and Regional Clerk are hereby authorized and directed to execute a Certificate of Approval pursuant to the Act.
- 3. The Region, as expropriating authority, expropriate the following lands by the preparation, execution and registration of a plan of expropriation:

The permanent easements are required for the purpose of entering on the lands with all vehicles, machinery, workers and other material (I) to construct and maintain permanent municipal infrastructure which may include retaining walls, shoring and formwork and/or drainage, erosion or sediment control measures such as water mains and storm sewers; and (II) for construction purposes which may include (1) relocation of existing services and utilities, (2) staging and storage of materials and equipment, (3) geotech testing, borehole testing, and other investigative works, (4) removal, relocation and/or installation of signage, (5) hard and soft landscaping, paving, grading and reshaping the lands to the limit of the reconstruction of Yonge Street, (6) the installation and removal of temporary (i) pedestrian access and walkways, (ii) parking measures including re-striping of aisles, lanes, and parking stalls, (iii) shoring and formwork, (iv) drainage and erosion/sediment control measures, (v) traffic signals, (vi) fencing, and (vii) handrails, and (7) works ancillary

to any of the foregoing.

The four year temporary easements will commence upon registration of an expropriation plan and are required for the purpose of entering on the lands with all vehicles, machinery, workers and other material for construction purposes, which may include (1) relocation of existing services and utilities, (2) work that supports the construction of municipal infrastructure within the Region's permanent takings, (3) staging and storage of materials and equipment, (4) geotech testing, borehole testing, and other investigative works, (5) removal, relocation and/or installation of signage, (6) hard and soft landscaping, paving, grading and reshaping the lands to the limit of the reconstruction of Yonge Street, (7) the installation and removal of temporary (i) pedestrian access and walkways, (ii) parking measures including re-striping of aisles, lanes, and parking stalls, (iii) shoring and formwork, (iv) drainage and erosion/sediment control measures, (v) traffic signals, (vi) fencing, and (vii) handrails, and (8) works ancillary to any of the foregoing.

- 4. The Commissioner of Corporate Services is authorized to cause the said plan or plans to be registered in the proper Land Registry Office, to give notice of such expropriation in accordance with the Act and to execute all necessary documents to effect the transaction.
- 5. Plan Nos. 65R-34760, 65R-34732, 65R-34733, 65R-34764, 65R-34773, 65R-34769, 65R-31421, 65R-34772, 65R-34737, 65R-34771, 65R-34768, 65R-34759, 65R-13950, 65R-35077, 65R-35071, 65R-35072 and 65R-35076, hereto attached, shall form part of this bylaw.
