BYLAW NO. 2014-63

To acquire certain lands for or in connection with the widening and reconstruction of St. John's Sideroad (YR 26) from Bayview Avenue (YR 34) to Highway 404, Town of Aurora

WHEREAS the Council of The Regional Municipality of York on June 26, 2014, by its adoption of Clause 26 of Report 12 of the Committee of the Whole authorized an application for approval to expropriate the lands therein referred to for or in connection with the widening and reconstruction of St. John's Sideroad (YR 26) from Bayview Avenue (YR 34) to Highway 404, in the Town of Aurora; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS no notification of a desire for a hearing has been received and the time for giving such notification has expired; and

WHEREAS the Council of The Regional Municipality of York on September 11, 2014, by its adoption of Clause 42 of Report 13 of the Committee of the Whole approved the expropriation of the hereinafter described lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the lands referred to in section 3 is hereby approved for or in connection with the widening and reconstruction of St. John's Sideroad (YR 26) from Bayview Avenue (YR 34) to Highway 404, in the Town of Aurora.

- 2. The Regional Chair and Regional Clerk are hereby authorized and directed to execute a Certificate of Approval pursuant to the *Expropriations Act*.
- 3. The Region, as expropriating authority, expropriate the following lands by the preparation, execution and registration of a plan of expropriation:

Fee Simple Interest:

Part 1 on Plan 65R-34919

Parts 1, 2, 3, 4, 5 and 6 on Plan 65R-34920

Parts 1, 2, 3 and 4 on Plan 65R-34921

Parts 2 and 3 on Plan 65R-34925

Parts 2, 4, 15 and 16 on Plan 65R-34927

Permanent Easement Interest:

Part 3 on Plan 65R-34927

Temporary Easement Interest:

Part 4 on Plan 65R-34925

Parts 1 and 17on Plan 65R-34927

(for a period of five years commencing upon registration of the expropriation plan)

- 4. The Commissioner of Corporate Services is authorized to cause the said plan or plans to be registered in the proper Land Registry Office, to give notice of such expropriation in accordance with the *Expropriations Act* and to execute all necessary documents to effect the transaction.
- 5. Plan Nos. 65R-34919, 65R-34920, 65R-34921, 65R-34925 and 65R-34927, hereto attached, shall form part of this bylaw.
