With the contribution of the Regional Municipality of York Police Services Board and members of the Executive Command Team, the Corporate Communications Bureau developed the 2013 Annual Report which profiles our accomplishments from the last year. The report includes a summary of high-profile investigations, information on community engagement and crime prevention programs, a feature on women in policing, organizational and individual awards, statistical reporting and our 2011 to 2013 Business Plan accomplishments.

FINANCIAL IMPLICATIONS

In-house resources and expertise were utilized to write and design the 2013 Annual Report. The only cost associated with the report is for print production, which will cost \$8,740 for 2,500 copies. Funding is included in the existing 2014 budget details for external printing.

BACKGROUND

The Ministry of Community Safety and Correctional Services Policing Standard 001-0049 Framework for Annual Reporting Guideline states that, pursuant to Section 31 of the Adequacy Standards Regulation, every Chief of Police prepare for the police services board, an annual report on the activities of the police service during the previous fiscal year which includes information on performance objectives; indicators and results; public complaints; and the actual cost of policing.

In addition, section 32 of the Adequacy Standards Regulation requires a police services board to enter into a protocol with its municipal council that sets out the date by which the annual report will be provided to municipal council, the responsibility for making the annual report public and the date by which it will be made public.

The York Regional Police 2013 Annual Report addresses ministry reporting requirements and aims to provide the Regional Municipality of York Police Services Board and our community with an overview of our accomplishments in 2013. The report, while strictly adhering to ministry reporting guidelines, is engaging, informative and easy to read.

As a transparent organization whose mission is to ensure our citizens feel safe and secure through excellence in policing, York Regional Police is proud to provide the 2013 Annual Report which details a summary of our efforts and accomplishments in the area of community safety, crime prevention and enforcement. It gives York Regional Police an opportunity to communicate directly with our community and allows our community to share in our accomplishments and successes in our crime prevention and law enforcement programs and activities.

The 2013 Annual Report will be disseminated to the Regional Municipality of York Police Services Board, Regional Municipality of York Council, York Regional Police members, mayors, councillors, MPs, MPPs, community groups, libraries, school boards, emergency services and community partners and support agencies.
