BYLAW NO. 2014-49

To acquire certain leasehold interests in lands for or in connection with the widening and reconstruction of Davis Drive (YR 31), in the Town of Newmarket

WHEREAS the Council of The Regional Municipality of York on May 15, 2014, by its adoption of Clause 16 of Report 10 of the Committee of the Whole authorized an application for approval to expropriate the leasehold interests therein referred to for or in connection with the widening and reconstruction of Davis Drive (YR 31), in the Town of Newmarket; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS no notification of a desire for a hearing has been received and the time for giving such notification has expired; and

WHEREAS the Council of The Regional Municipality of York on June 26, 2014, by its adoption of Clause 24 of Report 12 of the Committee of the Whole approved the expropriation of the hereinafter described leasehold interests in lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the leasehold interests in lands referred to in section 3 is hereby approved for or in connection with the construction of the bus rapid transit corridor, on Davis Drive (YR 31), in the Town of Newmarket.
