

Clause No. 3 in Report No. 12 of the Committee of the Whole was adopted, without amendment, by the Council of The Regional Municipality of York at its meeting held on June 26, 2014.

# **3** CONDITIONAL 2014 CONSERVATION AUTHORITIES FUNDING

Committee of the Whole recommends adoption of the recommendations contained in the following report dated June 5, 2014 from the Commissioner of Finance:

#### 1. **RECOMMENDATIONS**

It is recommended that:

- 1. Committee receive the correspondence from the Lake Simcoe Region Conservation Authority and the Toronto and Region Conservation Authority, included as *Attachments 1 and 2* to this report.
- 2. Council approve funding of \$394,000 for the Lake Simcoe Region Conservation Authority, for the purposes identified in Table 1 of this report.
- 3. Council defer the conditional funding of \$500,000 for the Kortright Municipal Servicing capital project for the Toronto and Region Conservation Authority.
- 4. The Regional Clerk circulate this report to both Conservation Authorities.

#### 2. PURPOSE

This report provides an update on conditional approvals of additional funding for Conservation Authorities in the 2014 budget. These approvals were contingent on the Authorities' securing partner funding.

### 3. BACKGROUND

#### **Council provided conditional funding for the Conservation Authorities**

At its meeting of December 19, 2013, Regional Council approved \$894,000 in additional funding for the Conservation Authorities, provided that they could obtain the necessary contributions from other partners. The conditional funding is outlined in Table 1.

#### 4. ANALYSIS AND OPTIONS

#### York Region is the largest contributor to the Lake Simcoe Region Conservation Authority

Nine municipalities contribute to the LSRCA annual general levy according to their share of Current Value Assessment (CVA) in the watershed. Table 2 summarizes the municipalities and their share of the LSRCA general levy for 2014.

The LSRCA has identified five municipalities as "growth partners": York Region, the City of Barrie, Durham Region, the Town of Bradford West Gwillimbury, and the Town of Innisfil. These five municipalities account for 96.76% of the LSRCA 2014 annual general levy. Because the smaller municipalities in the LSRCA watershed lack fiscal capacity, LSRCA has begun to ask the "growth partners" for additional capital and operating funding, over and above its general levy.

#### LSRCA has secured full growth partner funding for the Scanlon infrastructure capital project and partial funding for the operating requests

LSRCA advised Regional staff on March 20, 2014 that a total of \$66,435 has been secured from other growth partners for the Scanlon infrastructure capital project. In addition, the Lake Simcoe Conservation Foundation Board has approved a contribution of \$35,000 to support this project.

Durham Region, the Town of Innisfil and the Town of Bradford West Gwillimbury have approved the additional administrative staffing costs, the operating costs for the Scanlon Education Centre, and the data security and management project costs. The City of Barrie did not contribute to these projects.

Table 3 summarizes the financial support from the growth partners for the additional initiatives. This funding is in addition to York Region's funding summarized in Table 1.

## LSRCA has developed a plan to address the 2014 shortfall of \$72,751

Without support from the City of Barrie, a shortfall of \$38,470 exists for the three staff positions. LSRCA has indicated that they are able to reallocate within their existing budget to offset this shortfall for 2014.

Due to a delay in the capital infrastructure works related to the air quality assessment, a portion of the Scanlon Education Centre has not been opened. As a result, the operating funding from the four contributing growth partners (minus Barrie) is sufficient for 2014.

In addition, LSRCA will stage the data security and management project to stay within the available funding in 2014.

# York Region is the second largest contributor to the Toronto and Region Conservation Authority

Six municipalities contribute to the TRCA annual general levy according to their share of Current Value Assessment (CVA) in the watershed. Table 4 summarizes the municipalities and their share of the TRCA general levy for 2014.

# TRCA has not yet secured partner funding for the Kortright municipal servicing project

York Region support of the Kortright project was approved contingent upon securing funding from other growth partners (City of Toronto, Durham Region, and Peel Region). TRCA advised Regional staff on March 27, 2014 that funding has not yet been secured. TRCA is engaged in discussions with local developers to secure funding for the project in 2014.

### Link to key Council-approved plans

York Region provides funding for LSRCA and TRCA programs for water restoration works, stewardship efforts, and stream flow monitoring of the watersheds in the Region. These initiatives support the 2011-2015 Strategic Plan objective to continue to partner with all levels of government to facilitate the delivery of environmentally-sustainable infrastructure.

## 5. FINANCIAL IMPLICATIONS

# The total cost of the Scanlon capital infrastructure project is \$1,037,600 over three years, with York Region responsible for almost 70% of the cost

The Scanlon capital infrastructure project is to retrofit the Scanlon Creek Education Centre building located in the Town of Bradford West Gwillimbury to accommodate the growing number of LSRCA staff and programs. It is estimated that the total project cost for the Scanlon property is \$1,037,600 over a three-year period. The project has three elements: the Scanlon Creek Education Centre retrofit work for \$667,600, fibre optic internet services for \$220,000, and the Scanlon Creek Nature Centre facility retrofit work for \$150,000.

Table 5 shows the distribution of costs for the project. The costs beyond 2014 would need to be considered as part of the 2015 budget process.

#### Funding will be required for continuing operation of the Scanlon Education Centre

As noted in Table 1, total 2014 operating costs for the Scanlon facilities were estimated by LSRCA to be \$63,000. Council approved conditional funding of \$40,000 for York Region's share of these costs. LSRCA anticipates operating costs of \$97,000 in 2015, with York Region's share estimated at \$51,000. The cost estimates are based on the planned use of the premises. LSRCA will request support for these operating costs from growth partners as part of the 2015 budget request.

#### Kortright municipal servicing is estimated to cost \$3.6 million over four years, with York Region funding 84.5% of the cost

The Kortright municipal servicing project is to upgrade the existing water and wastewater infrastructure system for the Living City Campus at Kortright. The current single-well water system is costly to maintain, requires constant monitoring, limits the potential for future expansion on the property, and has no back-up supply. In addition, elevated concentrations of nitrate (just below the Ontario Drinking Water Standard of 10 mg/l) have been detected in a sentry well located between the on-site septic system and the supply well. The funding is intended to support the extension of municipal services to the Kortright property line, and the installation of new water and wastewater service lines to various buildings.

At the time the budget was considered in December 2013, the total project cost was estimated to be \$3.0 million. TRCA advised of a revised project cost of \$3.55 million in a subsequent communication dated March 27, 2014 (see Attachment 2, page 4). Table 6 shows the distribution of costs for the project.

\* TRCA has indicated that they are currently working with local developers to determine a cost sharing formula or other mechanism for developer funding.

TRCA has not apportioned the project costs to all of its municipal partners or to a subset of them. TRCA general practice is to seek capital funding for large projects from the municipalities in which the project is located.

It is very unlikely that TRCA will be able to secure significant partner funding for the Kortright servicing project. The request for a multi-year \$3.0 million contribution from York Region would need to be re-considered as part of the 2015 budget process.

### 6. LOCAL MUNICIPAL IMPACT

The Conservation Authorities deliver programs and help York Region to meet its service objectives for residents and businesses in all local municipalities within York Region.

The TRCA funding request for municipal servicing is for the Kortright Centre, which is located in the City of Vaughan.

## 7. CONCLUSION

Staff are of the view that the LSRCA has obtained sufficient partner contributions to release their conditional funding, whereas the TRCA has not yet been able to obtain sufficient partner funding.

There are significant future costs associated with the Conservation Authorities' requests that will need to be considered in the 2015 budget process.

#### Re: Partner Funding Update for 2014 Additional Request

I want to thank you for the opportunity to meet with yourself and CAO's Bruce Macgregor and Gayle Wood on February 26, 2014 to further discuss the Lake Simcoe Region Conservation Authority's (LSRCA) 2014 budget. This meeting has assisted me and our CAO in taking the appropriate steps in addressing Council's resolution regarding our 2014 budget request.

The recommended outcome from the December 12<sup>th</sup>, 2013 Committee of the Whole meeting reflected in the December 19<sup>th</sup>,2013 Council report provided the following decision with respect to LSRCA's additional funding request;

- 1. Additional funding of \$110,000 for Compensation adjustment and \$41,000 for Emerald Ash Borer program. Our understanding is that this funding is not conditional and no further follow up is required.
- 2. Additional funding of \$129,000 for staffing costs to support administrative operations, \$40,000 for Scanlon Creek facilities operation, \$75,000 for data security and management, all of these items contingent upon funding participation from other growth partners. It is our understanding that Council anticipates that funding will be matched, based on our cost sharing apportionment formula, from the municipalities of Durham, Bradford-West Gwillimbury, Innisfil and Barrie.
- **3.** Additional \$150,000 for Scanlon Infrastructure Capital contingent upon securement of additional funding from other growth partners and a staff report confirming securement of partner funding and identifying the financial implications for the Region. It is our understanding that Council anticipates that funding will be matched, based on our cost sharing apportionment, from the municipalities of Durham, Bradford-West Gwillimbury, Innisfil and Barrie. Further, it is understood that York Region Staff will prepare and submit to the Committee of the Whole on June 19<sup>th</sup> a report in this regard.

LSRCA sought an additional budget request to our five (5) growth partners, York Region, Durham Region, City of Barrie, Town of Innisfil, and Town of Bradford West Gwillimbury in 2014. Following is an outline of the response that we received from our partners, in relation to the York Region resolutions reflected above.

# Lake Simcoe Region conservation authority

- 1. All five growth partners have contributed to the LSRCA's compensation adjustment. Further, the Emerald Ash Borer Program is specific to York Region. Although this funding was not conditional, from York Region, we are pleased to report that our five growth partners have supported our requested compensation adjustment.
- 2. Four of the five growth partners supported the additional staffing costs, Scanlon Education Centre operations and data security and management. The City of Barrie did not contribute to these costs. Their share of the staffing costs is \$38,470, Scanlon operating costs \$11,924, and data security costs \$22,357. In a meeting with the City of Barrie staff, it was suggested that the request for funding would be received better in the 2015 budget year. LSRCA will request the funding for these items in 2015.
- 3. For the Scanlon Education Centre capital project all requested funding for 2014 has been approved by the funding partners. Additionally, LSRCA is prepared to contribute \$35,000 bringing the total available funding for the project to \$251,000 for 2014, which includes York Region's contribution of \$150,000. The Lake Simcoe Conservation Foundation is presenting to their Board on March 20, 2014 staff's recommendation for funding support to LSRCA. Included in the recommendation is \$35,000 for the Scanlon Education Centre capital work. LSRCA believes that it has met York Region's condition that their funding for the Education Centre is matched by the affected growth partners. For details of this project please see Attachment 1 (a) and Attachment 1 (b).

The chart provided in Attachment 2 demonstrates the funding received for each item requested from the funding partners and their contribution.

In relation to resolution #2 above, for the Scanlon Education Centre operating costs, due to a delay in the capital infrastructure works related to the air quality assessment, operating costs have not ramped up for the 2014 year. Please see Attachment 1 (a) for details relating to the operating costs.

For the 2014 budget purposes we had anticipated that we would already be utilizing a portion of the building and the costs were estimated based on the ramped up level. Sufficient funding to cover the lower cost level is available from the funding partners that have contributed and we believe this funding is sustainable and will eliminate the need to draw on the working-capital reserve as was required in prior two years.

Also related to resolution #2 above, LSRCA has reviewed internal budget priorities and revenue streams other than municipal funds, to determine the appropriate allocation of general levy. To offset the shortfall of the City of Barrie's contribution to the staff positions, general levy has been allocated for the three staffing positions to ensure sustainable funding is in place. Please see Attachment 3 for details relating to the staffing positions.

The data security infrastructure work can be done in stages as most of the work involves upgrading computers, servers, switches, and storage area networks. The 2014 work will be completed to the degree that has been funded, moving some of the upgrade work to 2015. LSRCA will pursue the City of Barrie's share in the 2015 budget year.

#### LSRCA Attachment 1 (a)

#### **Scanlon Capital Projects**

The Scanlon Education Centre building was utilized in 2011 for the overnight education program. The York Region School Board withdrew from the overnight program in 2011, and the Authority was faced with a decision regarding a major asset. Three options were considered; lease building, demolish building, or repurpose building for LSRCA's use. LSRCA's 20 year physical infrastructure strategy for its priority facilities identified the need for more administrative space for staffing. Through multiple facility condition assessments that LSRCA engaged outside consultants to complete, the capital infrastructure investment required to bring the Education Centre building into a state of good repair was identified. Attachment 1 (b) provides a listing of the proposed works and staging.

The capital infrastructure upgrade project requires a total investment of approximately \$667,600 over a three year period, covering \$165,850 for architectural work, \$214,750 for mechanical work, and \$137,000 for electrical work. Currently LSRCA is undergoing an air quality assessment review that will help to isolate specific works that need to be completed.

Additionally for the Scanlon property, \$150,000 was required for the Nature Centre building, and \$220,000 for the fiber optic internet services.

The total capital project cost for the Scanlon property of \$1,037,600 was distributed over a three year period with the work being staged. York Region's contribution in 2014 is \$150,000. For the remaining two years, 2015 and 2016, the capital contribution amount for York Region's share would be \$286,311 for each year.

#### Scanlon Education Centre Operating Costs

In 2012 and 2013 the Education Centre building was not used, however, there were on-going nondiscretional maintenance costs that LSRCA was committed to for items such as utilities, heat, insurance, and the water treatment maintenance that is tied to the Nature Centre building which is used for the day time Education program. These costs run at about \$40k per year. For 2012 and 2013 LSRCA had to cover these ongoing costs using the unallocated working capital account which was established through Board approval in 2010 for covering corporate budget-year to budget-year transitions, bridging of ongoing expenditures while sustainable funding is secured, and one-time costs. When the decision was made to repurpose the building for LSRCA's use, we immediately included a request to our funding partners for a sustainable funding stream and requested an amount that represented the operational cost level based on expected return to use of the premises.

#### LSRCA Attachment 3

#### **Staffing Position Details**

Funding for three administrative positions was requested as part of the 2014 budget "Ask". The positions are;

- 1. Senior Administrative Assistant (for the General Manager, Communications)
- 2. Communications Specialist
- 3. HR Generalist

The Senior Administrative Assistant and the Communications Specialist are existing positions for which sustainable funding is required.

The Senior Administrative Assistant role has been funded over the past couple of years using temporary funding streams available from the CAO's office, due to an open position which is now filled. This role is a key support position for the General Manager, Communications. Sustainable funding is being sought for the on-going needed position.

The Communications Specialist is an existing role. Originally the role was 90% funded by the province under the Source Water Drinking program (SWP). As the program has changed and demand on this role has been reduced for SWP, and there has been increased demand on the Communications role from other programs within the organization, as a result replacement funding is required.

The HR Generalist role is a new position. Both the volume of work within the HR department and the required health and safety compliance matters are driving the need for this position. Excessive overtime has been spent by the HR Manager for the past year and half trying to maintain the current service level. Health and safety compliance issues are mandatory. To add to the workplan challenges for this department of two persons, one will be going on maternity leave in June of 2014 and some of the lost continuity and knowledge will impact the HR Manager's workload even more. To help compensate for this adjustment, the maternity leave replacement will be hired several weeks earlier in the timeline to help bring the replacement person up to speed sooner, through training with the existing staff person. Following the maternity leave replacement hire the permanent additional HR Generalist position will be recruited.

All three of the above positions are required to sustain existing service levels.

#### Re: Toronto and Region Conservation Authority Budget—Kortright Municipal Servicing

We are writing in response to Ms. Chan's email of March 4th 2014 requesting information on our progress in securing additional funding from other growth partners. At this time we have, and are continuing, to pursue additional funding to meet the intent of the Council resolution. As you will see from the attached charts we have secured funding from various sources now totaling approximately \$2,100,000, for The Living City Campus at Kortright. We would hope that our actions to date would be sufficient to release these funds. If further securement of funds related to servicing is required, we would respectfully request that the 2014 allocation be protected until we can fulfill the requirements to the satisfaction of the Office of the Budget and Council.

At the meeting of Regional Council on December 19, 2013, the Region of York's TRCA budget was amended to include:

"an additional \$500,000 for Kortright municipal servicing contingent upon securement of additional funding from other growth partners and a staff report confirming securement of partner funding and identifying the financial implications for the Region."(Details outlined in Table 2)

Our original request for a three year \$3 million (\$1 million per year) allocation for municipal servicing from the Region was based on estimates prepared in 2011 (Water Services) and 2013 (wastewater). Staff is currently refining these estimates and is working with local developers to determine a cost sharing formula or other mechanism to assist. Realistically we cannot anticipate more than \$500,000 from the development industry. We are also assessing the ongoing operating costs so that we can identify the future impacts for TRCA and hence consider how this may impact future operating requests to the Region. In addition to the \$500,000 requested from York Region in 2014, we respectfully request that support be continued in 2015 and 2016 at a level of \$1,000,000 per year, and \$500,000 in 2017.

<u>Sent via email</u> bill.hughes@york.ca As we work to refine our engineering requirements, we are continuing to pursue fundraising efforts for both Kortright and the development of the BRE Innovation Park which will be serviced in part through this municipal servicing. In December 2013 we secured a \$500,000 grant for the development of the BRE project of which we can assign a portion to the provision of servicing for the site. *Table 1* outlines funding or in-kind support we have raised to further the retrofit of the Kortright building, in support of the development of the Innovation Park, and/or to continue to test products to demonstrate and quantify their performance to accelerate industry uptake to foster sustainable development. This includes a current \$25,000 in kind donation from Fleming College for a wastewater design that will service the BRE Innovation Park, potentially reducing the extent of municipal wastewater servicing required.

While we will continue to seek additional funding sources, we see York Region servicing support as critical to the development and securement of the provision of municipal water to the site and potential wastewater servicing or treatment. In reviewing the New Building Canada Fund we have determined that new applications will be accepted shortly. With the Region's support, we may be able to secure funding through that avenue further reducing the need for municipal support.

We will continue to update you as we move forward with our fundraising activities, consolidate the cost estimates and evaluate the Fleming College Design including its review with the City of Vaughan. In the meantime we request that you consider a joint New Building Canada Plan funding proposal and direction on how we can move that forward.
