Compensation Adjustment	On-going	\$110	\$110	Addresses estimated gap between current compensation and market levels.
Capital Support Agreement (6 FTEs)	On-going	\$503	\$0	York supports a service level agreement for growth related capital projects in the LSRCA watershed. York and LSRCA to continue to meet and define expected service level support as required.
Staffing costs to support administrative operations (3 FTEs)	On-going	\$129	\$129*	As a result of population and program growth, LSRCA is requesting a Communication Specialist, Senior Administrator and HR Generalist.
Scanlon Facilities Operation	On-going	\$40	\$40*	Funding for periodic maintenance of the Education Centre facility.

Integrated Infrastructure Protection Works	On-going	\$270	\$270	Will help to reduce the risk of failure from river erosion at critical York Region infrastructure sites. This additional funding will increase total annual funding to \$1.0M and allow projects to be completed at more high priority remedial sites.
Emerald Ash Borer Response	On-going	\$200	\$100	Costing estimates may be high as tree removal on conservation land should be less complicated and costly than within developed areas. Additional funding expands EAB response from current budgeted level of \$50K, supporting additional hazard tree abatements in priority areas. Suggest reprioritize existing Stewardship and Regeneration program to address the difference between requested and recommended funds.
Kortright Municipal Servicing	2014-2016	\$1,000	\$0	Previous funding was granted to TRCA for servicing as part of original retrofit request in 2012 (Currently approved funding \$505K/year through 2016). Prior approved funding was used for unforeseen health and safety needs. York's total cost of the request is \$3.0M.
Black Creek Pioneer Village North Property Development	2014-2018	\$500	\$0	Business case does not clearly identify benefits to York Region. York's total cost of the request is \$2.5M.
