Updated Medical Exemption Process for COVID-19 Vaccines Update to York Region health care providers as of January 7, 2022

Ontario's Ministry of Health has issued new guidelines for medical exemptions to COVID-19 vaccines. Effective December 15, 2021, Ontarians with exemptions for medical reasons or who are participants in COVID-19 related clinical trials will, once verified, be eligible to download an enhanced vaccine certificate (with a QR code) from the Ontario Portal. This QR code will allow patrons access to settings requiring proof of vaccination in the same way a fully vaccinated individual would be able to.

Individuals who believe they are eligible for a medical exemption **must undergo a clinical assessment** by an Ontario physician (designated as "MD") or registered nurse in the extended class (designated as "Registered Nurse (Extended Class)", "RN(EC)", "Nurse Practitioner" or "NP") to determine if they are at risk to receiving any COVID-19 vaccine. Medical notes issued by out-ofprovince physicians will not be considered eligible for Ontario residents to receive a QR code.

If the exemption is confirmed, the medical professional will complete a **Statement of Medical Exemption Form** and submit to the health unit where the practice is located, such as York Region Public Health. A copy of this new form follows this message and can also be found on <u>york.ca/healthprofessionals</u> – *COVID-19 Information for Health Professionals.*

For a list of valid exemptions to COVID-19 vaccination, please see the Ministry of Health's <u>Medical</u> <u>Exemptions to COVID-19 Vaccination</u> guidance document.

The form will be received by the health unit, assessed and entered into the COVAXON system, allowing for the vaccine certificate and QR code to become available for the patient on the Ontario Portal.

York Region Public Health may contact the health professional if clarification or additional information is required to complete the medical exemption.

Any previously issued medical exemptions, for the purpose of obtaining a vaccine certificate for entry to settings where proof of vaccine is required, must be resent directly to the PHU.

Forms must be submitted directly from the health care practitioner, rather than the client. Forms may be faxed to Immunization Services at 1-866-258-2026.

Individuals without a clinical assessment from an Ontario health care professional will not be considered medically exempt from receiving the COVID-19 vaccine.

APPENDIX 1: Consent

Best Practices for Obtaining Consent to Collect, Use, and Disclose Personal Health Information

- Where possible, the health information custodian (HIC) should obtain signed written consent from the individual to whom the information relates or their substitute decision maker.
- The HIC may alternatively obtain consent verbally and submit a written attestation signed by the HIC.
- HIC's should ensure that the consent satisfies the conditions set out in the <u>Personal Health</u> <u>Information Protection Act</u>, 2004.

Sample Consent

I ______ have provided information regarding a medical exemption from receiving a COVID-19 vaccination. I consent to the information being collected, used, and disclosed for the following purposes:

- The information will be collected by my medical practitioner for the purpose of maintaining my health care record.
- The information will be disclosed to an Ontario public health unit to create a record of personal health information indicating my exemption from COVID-19 immunization.
- The information may be exchanged between my medical practitioner and the public health unit as may be needed to clarify or verify my exemption.
- It will be used and disclosed as required for the administration of Ontario's COVID-19 vaccination program as well as other purposes authorized and required by law. For example,
 - It will be disclosed to the Chief Medical Officer of Health and Ontario public health units where the disclosure is necessary for a purpose of the *Health Protection and Promotion Act.*
 - It may be disclosed, as part of my provincial electronic health record, to health care providers who are providing care to me.

Information disclosed to the Ontario public health units will be stored in a health record system under the custody and control of the Ministry of Health.

You may also be contacted by a hospital, local public health unit, or the Ministry of Health or its agent for purposes related to your medical exemption (for example, to check on the status of your exemption). If you wish to receive these follow up communications by email or text, please indicate this using the box below.

If you consent to provide information regarding your medical exemption from receiving a COVID-19 vaccination, and then change your mind, you may withdraw consent at any time. Withdrawing your consent does not have retroactive effect but would prohibit the Ministry's subsequent uses of your personal health information unless authorized by law. If you wish to withdraw your consent or have questions about doing so you may contact the Ministry of Health at <u>vaccine@ontario.ca</u>.

Sample Attestation

I, ______ (HIC) hereby attest that ______ (individual) has provided me with personal health information regarding their medical exemption from receiving a COVID-19 vaccination and that the individual has consented to the information being collected, used, and disclosed in a manner that meets the requirements of the *Personal Health Information Protection Act, 2004.* The consent was:

- Disclosure to the Chief Medical Officer of Health and Ontario public health units where the disclosure is necessary for a purpose of the *Health Protection and Promotion Act.*
- Disclosure, as part of the patient's provincial electronic health record, to health care providers
