York Region Accessibility Advisory Committee 2023 to 2026 Application and Committee Information

Volunteers Needed

The Regional Municipality of York (York Region) is seeking up to seven new citizen members to serve on the York Region Accessibility Advisory Committee for the 2023 to 2026 term.

About the York Region Accessibility Advisory Committee

The York Region Accessibility Advisory Committee (YRAAC) is a committee made up mainly of citizen volunteers. The Committee advises York Regional Council and York Regional Police on making it easier for people with disabilities to use Regional programs, services and facilities.

Committee members come from different backgrounds and majority of members must be people with disabilities. The Committee term runs from 2023 to 2026. The YRAAC is required under the Accessibility for Ontarians with Disabilities Act, 2005 (AODA) and has responsibilities under the Act. Role of the York Region Accessibility Advisory Committee

The York Region Accessibility Advisory Committee (YRAAC) is a committee appointed by, and reporting to York Regional Council, and is required by the Accessibility for Ontarians with Disabilities Act, 2005 (the Act). It provides advice to York Regional Council and York Regional Police to make it easier for people with disabilities to access its programs, services and facilities.

Membership Composition

As per Council-approved Terms of Reference, the York Region Accessibility Advisory Committee will have a minimum of seven to a maximum of fifteen members from across the Region including three members of Council. The Regional Chair is an exofficio member. The majority of members must be residents of York Region with a range of disabilities representative of urban, urbanizing and rural areas of York Region.

Membership may also include York Region residents who may not have a disability but may be selected based on their interest or expertise in the identification, removal, and prevention of barriers, or individuals who may not be a resident of York Region, but are from organizations representing people with disabilities that provide services to York Region residents.

York Regional Council has final approval of the representatives to ensure the York Region Accessibility Advisory Committee is reflective of the diversity of York Region and the disability community.

To support the delivery of the York Region Accessibility Advisory Committee's mandate, preference will be given to persons with experience and knowledge of accessibility matters, including accessibility legislation and disability awareness.

Eligibility Considerations

Individuals appointed to the York Region Accessibility Advisory Committee will:

- Be eligible to vote in York Region, as set out in the Ontario Municipal Elections Act, 1996. Individuals who represent organizations, that provide services in York Region, to the Region's residents with disabilities, may be appointed to the York Region Accessibility Advisory Committee without having to be eligible to vote in York Region.
- 2. Not be engaged in any unresolved litigation with the Region or its Boards.
- 3. Not be an employee of York Region and York Regional Police.

Meetings

The York Region Accessibility Advisory Committee members are required to attend approximately five meetings each year. There are, generally, no meetings in July and August.

Meetings are currently held virtually, except as otherwise directed. If directed, in person meetings are typically held at the York Region Administrative Centre, located at 17250 Yonge Street in the Town of Newmarket.

Meeting material is available in accessible formats and with communication supports upon request. Accommodations are provided during the meetings.

Applying to Become a Citizen Member

To apply to become a citizen member, please complete the 2023 to 2026 York Region Accessibility Advisory Committee Application Form. **The deadline to apply is Monday, October 31, 2022.**

We sincerely thank everyone who applies, but only applicants selected for an interview will be contacted. We expect to contact people for interviews in late November 2022. Final appointment to the Committee is planned by the spring of 2023.
