1. Introduction

On March 7, 2018, the Minister of Natural Resources and Forestry issued a Declaration Order (Order) to separate proposed modifications to the York Durham Sewage System (Project) from The Regional Municipality of York's (York Region) proposed Upper York Sewage Solutions project and declared that the undertaking is not subject to section 5 of the *Environmental Assessment Act*. This exemption applies to the construction of new sanitary sewer forcemains and alterations to the Newmarket and Bogart Creek sewage pumping stations in the Town of Newmarket.

A Compliance Monitoring Program was submitted to the Ministry of Environment, Conservation and Parks (MECP), formerly the Ministry of the Environment and Climate Change (MOECC), in January, 2019 in accordance with Condition 4 of the Order. This Annual Compliance Monitoring Report was prepared in accordance with Condition 5 of the Order and outlines the results of the Compliance Monitoring Program.

The Condition 5 of the Order reads:

- 5.1 York Region shall prepare an annual Compliance Monitoring Report which outlines the results of the Compliance Monitoring Program for the previous 12 month period;
- 5.2 The first Compliance monitoring report shall be submitted to the Director within one year and one month from the date of this order set out below;
- 5.3 Subsequent Compliance Monitoring Reports shall be submitted to the Director on the annual anniversary of the first Compliance Monitoring Report each year thereafter;
- 5.4 York Region shall submit the Compliance Monitoring Report annually until all conditions in this order and any commitments made by York Region are satisfied, unless notified by the Director that annual reporting is no longer required.

The Director referenced in Condition 5 refers to the Director of the MECP Environmental Assessment and Permissions Branch.

2. Objectives

- To track implementation and completion of all commitments made by York Region through the development of the York Durham Sewage System Twinning Report (February, 2018) (Table 1);
- To monitor all Conditions of the Declaration Order dated March 7, 2018 (Table 2);
- To ensure accountability on implementation of the Project commitments and Conditions that is trackable and easy to audit, using grey shading to indicate completed commitments.
