- Store sterile equipment in a manner to prevent contamination.
- Use dental equipment, supplies and hand hygiene products that are not expired.
- Prepare injectable medications immediately prior to administration.
- Maintain a one-way workflow from dirty to clean in the reprocessing area.
- Perform cleaning of reusable semi-critical and critical dental equipment using friction with a detergent or enzymatic solution.
- Provide hand hygiene facilities and perform hand hygiene in accordance with infection prevention and control best practices.

Initial Report Comments:

HPPA Section 13 Order was issued on 2025/09/09, requiring the operator to cease providing dental services that require the use of reusable semi-critical and critical equipment until conditions related to the cleaning and sterilization of semi-critical and critical equipment, management of single-use equipment and hand hygiene are corrected.

York Region Public Health notified patients who received dental procedures at the clinic between 2015 and September 9, 2025. Patients were advised to seek testing for Hepatitis B, Hepatitis C and Human Immunodeficiency Virus (HIV).

IPAC lapse was posted after patient notification had occurred in accordance with the Infection Prevention and Control Disclosure Protocol, 2022.

Re-inspections were conducted on October 7, October 17, October 27, October 30 and October 31. On October 31, the Operator fully demonstrated the correct procedures for the cleaning and sterilization of reusable semi-critical and critical dental equipment, management of single-use equipment and hand hygiene. On October 31, 2025, York Region Public Health permitted the operator to resume dental services that require the use of reusable semi-critical and critical equipment.
