Summary Description of the IPAC Lapse

- Multidose vials, single-use vials, ointments, eye drops, and single-use injectable gel implants were not used, handled, labelled, stored, maintained, and discarded in accordance with the product monograph, manufacturer's instructions for use and "PIDAC Best Practices for Infection Prevention and Control for Clinical Office Practice April 2015" on safe preparation and administration of injectables.
- Sterile medical supplies were not stored in a clean, dry, dust-free area and kept away from sinks, debris, drains, and moisture.
- Reusable equipment/instruments used for aesthetic procedures (e.g., treatment of skin concerns, scars, pigmentation, skin tightening, hair removal, and facials) were not cleaned manually using detergent or enzymatic cleaner and water or mechanically using an ultrasonic cleaner or a washer-disinfector.
- Reusable equipment/instruments used for aesthetic procedures (e.g., treatment of skin concerns, scars, pigmentation, skin tightening, hair removal, and facials) were not disinfected using a disinfectant solution that was appropriate for the intended use of the equipment/instruments.
- Reusable equipment/instruments used for aesthetic procedures that require sterilization were not being sterilized after each use.
- Hand hygiene was performed in a sink that was not dedicated for hand hygiene only.
- Alcohol-based hand rub products used on premises for hand hygiene were expired.

- Stop the practice of pre-filling-injectable products in advance, for their later use in accordance with "PIDAC

		Best Practices for Infection Prevention and Control for Clinical Office Practice April 2015". • Store sterile supplies in a clean, dry, dust-free area, and keep them away from sinks, and protected from debris, drains, and moisture. • Clean, and disinfect or sterilize all reusable equipment/instruments as per manufacturer's instructions for use, and in accordance with the "Public Health Ontario: Guide to Infection Prevention and Control in Personal Service Settings, 3rd Edition, July 2019" or "Public Health Ontario: Best Practices for Cleaning, Disinfection and Sterilization of Medical Equipment/Devices In All Health Care Settings, 3rd edition, May 2013," as applicable. • Clean reusable tools manually using detergent, or enzymatic cleaner and water or mechanically using an ultrasonic cleaner or a washer-disinfector. • Prepare and use disinfectants that are intended and approved for disinfection of reusable equipment/instruments, ensuring the disinfectant selected is compatible with the tools being disinfected and holds a valid Health Canada Drug Identification Number (DIN) or Medical Device Active Licence Listing (MDALL). • Perform hand hygiene in a designated handwashing sink that is not used for any other purpose, or by using Alcohol-Based Hand Rub, when hands are not visibly soiled. • Use alcohol-based hand rub that is not expired.

HPPA Section 13 Order was issued on 2026/06/24. The operator was ordered to stop the use of the Skin Aqua Facial Hydrafacial VS-B device, Mesotherapy device, and Removal Sweep Spot Pen device for the provision of personal services. The operator was further ordered to stop the provision of personal services that involve the use of equipment/devices requiring high-level disinfection or sterilization. The operator was ordered to ensure all reusable equipment/devices and instruments are cleaned, and disinfected or sterilized as per manufacturer's instructions for use that are in accordance with the "Public Health Ontario: Guide to Infection Prevention and Control in Personal Service Settings, 3rd Edition, July 2019" or "Public Health Ontario: Best Practices for Cleaning, Disinfection and Sterilization of Medical Equipment/Devices In All Health Care Settings, 3rd edition, May 2013," as applicable.
