

ABOUT THE REGIONAL FOREST



- 22 tracts, totaling approximately 2,400 hectares
- 150+ kilometres of trails for public use
- 1 tract with a fenced dog off-leash area (Bendor and Graves Tract)
- Tracts in five of nine cities and towns in York Region


Approved uses include

- Walking / hiking (with and without dogs)
- Cycling, skiing, horseback riding



What is this project all about?

- York Region is exploring options for dogs in York Regional Forest
- This project was identified as a follow-up action in "It's In Our Nature" in 2019
- Dog walking is a popular activity that can sometimes create issues and conflicts with other visitors and activities



What is this project all about?

- York Region is committed to ensuring the Forest remains a safe and enjoyable place for all visitors while balancing ecological considerations
- Use of the Forest was increasing before COVID-19 and this trend has continued, including new visitors (with and without dogs), resulting in a greater number of complaints and reported incidents




WHAT IS THE PROJECT PURPOSE?

- To identify an approach to managing dogs in the Forest that respects the diversity of visitors, is compatible with the ecological objectives of the Forest, and supports a safe and inviting outdoor space for nature-based education
- The approach must also be enforceable, implementable and supported by local cities and towns



WHAT ARE THE TIMELINES?





Why is York Region asking for input?

- Your ideas count!
- York Region wants to understand preferences of all Forest visitors, whether they are dog owners or not, to enable a positive visitor experience
- Results from the public survey will be combined, alongside research findings and input from stakeholders and partners, into a report to York Regional Council





WHAT ARE THE RULES FOR DOGS?

Current rule: Dogs must be on-leash at all times



Rule before COVID-19: Dogs must be on-leash or under control at all times



WHAT HAS BEEN DONE ALREADY?

Phase 1: Background Review (Fall 2020, Winter 2021)

- Background research on the York Regional Forest
- Review of legislative and regulatory context
- Review of technical and scientific literature
- Stakeholder engagement
- Phase 1 survey and "What You Said" report

Phase 2: Option Selection (Spring 2021)

- Establish criteria for evaluating options
- Proposed rule and options
- Stakeholder engagement
- Phase 2 survey Available now for you to complete



WHAT WILL HAPPEN NEXT?

Phase 2 continued: (Spring and Summer 2021)

- Phase 2 Survey closes July 9
- Continued stakeholder engagement
- Selection of proposed rule and/or option(s)

Phase 3: Implementation Plan (Fall 2021 to Winter 2022)

- Publish "What You Said" report about Phase 2 Survey
- Implementation plan
- Report to Council
- Implement new rules





WHAT DID YOU SAY?

Phase 1 survey recap

- Nearly 2,000 residents and Forest visitors shared their thoughts 76% were dog owners or caregivers
- People (and their dogs!) visit at all times of the year, all times of the day
- Roughly a third of respondents reported having no concerns about dogs in either fenced or unfenced areas in the Forest
- About two-thirds of respondents identified a range of concerns.
 - The top concern (41%) was 'dogs not under control'
 - Other concerns: dog waste not being picked up and fear of being approached by an unfamiliar dog

WHAT DID WE LEARN?

Any rule and/or options that are chosen should...

- ✓ Consider the needs of visitors of various ages, backgrounds and abilities
- ✓ Limit risk of conflict with other permitted uses and ongoing management activities in the Forest
- ✓ Support a safe and inviting outdoor space for nature-based education
- ✓ Be consistent with the York Regional Forest's ecological objectives
- ✓ Be closely aligned with existing city and town animal control by-laws
- ✓ Have education and enforcement tactics that can be implemented with local city, town, and/or Region resources



WHAT OPTIONS HAVE BEEN CONSIDERED?

York Region reviewed and considered a full range of options including:

- 1. Dogs on-leash at all times in all tracts
- 2. Dogs permitted off-leash in all tracts
- 3. No dogs permitted in all tracts
- 4. Different rules for different tracts
- 5. Different rules for different trails in the same tract

Add-on: Fenced off-leash areas



HOW WERE THE OPTIONS CHOSEN?


We developed a set of criteria based on the engagement and research:

- 1. Potential to reduce conflict with other Forest uses
- 2. Supportive of positive visitor experience
- 3. Aligned with Forest programming
- 4. Compatible with ecological considerations
- 5. Easy to understand
- 6. Easy to enforce
- 7. Minimizes safety risks
- 8. Compatible with Forest management activities
- Cost effective





WHAT IS THE PROPOSED RULE?



Dogs remain on-leash at all times, in all York Regional Forest tracts, except in designated areas



WHAT ARE THE OPTIONS?



Option A: One to three tracts where dogs are permitted to be off-leash

and/or



Option B: One to three tracts where dogs would not be permitted

and/or



Option C: One to two additional fenced dog off-leash area(s)



IMPORTANT CONSIDERATIONS

- All, some or none of the options may be selected for implementation
- Other current rules will remain
 (e.g. stay on the trails, pick-up your pet's waste)
- The current fenced dog off-leash area at the Bendor and Graves Tract will remain
- Service dogs will continue to be permitted





IMPORTANT CONSIDERATIONS (continued)

- York Region is committed to ongoing education and enforcement for the proposed rule and all options
- Sites, if any, for the options, will be chosen based on various considerations such as location, tract size, and ecological sensitivity
- We'd like to hear from you about what we should be considering in tract selection for the different options



WHY CHANGE THE RULES?

This project is helping the Region better understand issues around dogs in the Forest to meet the objectives in the 'It's In Our Nature' plan.

The proposed rule of dogs-on leash everywhere would:

- Balance different visitor preferences to ensure the Forest is enjoyable for everyone
- Help protect sensitive ecological areas in the Forest
- Help make the Forest safer for all visitors and dogs
- Reduce potential conflicts with educational programming

The potential 'add-on' options recognize the history of off-leash activity and the desire to accommodate this preference in a manageable way.



RECAP: PROPOSED RULE AND OPTIONS



Dogs remain on-leash at all times in all York Regional Forest tracts except in designated areas.

PLUS all, some, or none of Options A, B, and C

Option A: One to three tracts where dogs are permitted to be off-leash



Option **B**: One to three tracts where dogs would **not be permitted**



Option C: One or two additional fenced dog off-leash area(s)
