1. Recommendations

It is recommended that Council receive this report for information.

2. Purpose

This report is a statement, required by legislation, of the remuneration and expenses paid in 2017 to:

- Each member of Regional Council, in respect of his or her services as a member of Regional Council or local board, and
- Each person, other than a member of Regional Council, appointed by the Council to serve as a member of a local board.

3. Background

An annual statement of remuneration and expenses is required by the Municipal Act

Section 284(1) of the Municipal Act requires the Regional Treasurer to provide an annual statement of remuneration and expenses to Council, on or before March 31, of amounts paid to members of Regional Council and appointees to local boards.

4. Analysis and Options

Remuneration and expenses for Members of Regional Council were paid from the operating budget

Regional Councillor remuneration is established under the authority of By-law No. A-215-96-132 and By-law No. A-215(a)-2000-001.

Attachment 1 summarizes the 2017 amounts paid to Council members in respect of his or her services as a member of Council. Funds were approved in the 2017 Regional Budget adopted on December 15, 2016.

Local municipalities pay the Members of Regional Council and are reimbursed by the Region

Under the terms of an agreement, salary and benefits are paid by the local municipalities to their respective members of Regional Council and recovered from the Region.

Annual remuneration for 2017 was \$55,234 from January 1 to March 31, and \$56,195 from April 1 onwards.

The small differences in remuneration among Councillors are due to variations in pay periods and benefits coverage among municipalities.

Payments from three Local Boards and Authorities to Regional Councillors and Appointees are included

In 2017, five Regional Councillors and one local municipal councillor were appointed to the Toronto and Region Conservation Authority. Similarly, four Regional Councillors and three local municipal councillors were appointed to the Lake Simcoe Region Conservation Authority.

Payments for their services to the Authorities are detailed in Attachments 2 and 3 respectively. The four local municipal councillors appointed to the conservation authorities are summarized in Attachment 4.

Expense reimbursements to Regional Councillors on the York Regional Police Services Board are reported in Attachment 5.

5. Financial Implications

Funding for remuneration and expenses for Members of Council is included in the annual operating budget.

6. Local Municipal Impact

The single payer arrangement between the Region and the local municipalities does not result in any increased costs to the local municipalities. Local municipalities invoice the Region for the Region's portion of salary and benefits based on payments to their respective Regional Councillors.

7. Conclusion

This report provides a statement, required by legislation, of the remuneration and expenses paid in 2017 to each Member of Council in respect of his or her services as a Member of Council, and to a Member of Council or other person who has been appointed by the Council to serve as a member of a local board or authority.

Section 247 (1) of the Municipal Act, R.S.O. (1990) requires municipal treasurers, to submit to Council a statement of remunerations and expenses paid in the proceeding year to each member of Council with respect to his/her services as an official of the municipality, membership on a local board or other body.

The individuals who were appointed to Toronto and Region Conservation Authority (TRCA) by the Council of the Region of York received the remuneration and expenses for 2017 outlined in Attachment 1. Per diem paid was \$86.62 per meeting per twenty-four hour period and the mileage rate was 50 cents per kilometre (\$0.50/km). Per diem was ½ the regular per diem rate (\$43.31) if participated in meetings by teleconference.

The Chair, as an elected municipal member, receives two-times per diem, as does the Vice Chair when acting in the place of the Chair (\$173.24). The Chair for 2017 was a City of Toronto appointee and the Vice Chair position was two Region of York appointees over the calendar year.

The noted remuneration rates were approved by the Ontario Municipal Board (OMB) in June, 2008. TRCA was authorized to pay the prescribed remuneration in 2017 as per Section 37 of the Conservation Authorities Act, R.S.O 1990, Chapter C.27.

Members are given the opportunity to collect, waive or donate remuneration and/or expenses. If a donation is requested, this is done internally by TRCA staff as a direct transfer from TRCA to The Living City Foundation, the charitable arm of TRCA. If the waive option is selected, the appointee does not receive any payment for remuneration and/or expenses as identified in the attached summary report.
