

Clause 9 in Report No. 5 of Committee of the Whole was adopted, without amendment, by the Council of The Regional Municipality of York at its meeting held on March 29, 2018.

#### 9 Disposal of Surplus Assets - 2017

Committee of the Whole recommends adoption of the following recommendation contained in the report dated March 1, 2018 from the Commissioner of Finance:

1. Council receive this report for information.

Report dated March 1, 2018 from the Commissioner of Finance now follows:

#### 1. Recommendation

It is recommended that Council receive this report for information.

#### 2. Purpose

This report advises Council of all actions taken by the Procurement Office regarding the disposal of obsolete, damaged or surplus tangible capital assets, excluding land, buildings and furniture, from January 1, 2017 to December 31, 2017.

In accordance with the Disposal of Surplus Assets Policy updated on April 20, 2017, a report shall be submitted to Council, on an annual basis, regarding the disposal of surplus assets.

#### 3. Background

### The Region has had a formal policy for disposing of surplus assets since 2003

On August 22, 2003, a formal policy was created that prescribed how the Region's assets were to be disposed of once they reached the end of their useful life. The policy was recently revised and the updated policy was adopted by

Council on <u>April 20, 2017</u>. Authority was delegated to the Director, Procurement Office to dispose of Regional surplus assets to maximize their residual value, excluding land, buildings, and furniture.

This policy identifies the approaches through which the Region disposes of its surplus assets, and protects confidential and sensitive data, in compliance with the Municipal Freedom of Information and Protection of Privacy Act and the Personal Health Information Protection Act.

#### Disposal of surplus assets is required to be reported annually

The Disposal of Surplus Assets policy requires that the Commissioner of Finance report to Council regarding the disposal of surplus assets, on an annual basis.

#### Methods of disposal are prescribed in the policy

The Disposal of Surplus Assets policy delegates authority to the Director, Procurement Office, to dispose of surplus assets using the following methods:

- 1. Trade-in the asset:
- 2. Offer the asset free of charge to other Regional departments;
- 3. Offer the asset at its net residual value to local municipalities; or
- 4. Sell the asset through an open and transparent process.

Where applicable, assets may also be disposed of through the Ontario Stewardship Program, a not-for-profit organization whose primary objective is to keep materials out of landfills, and to recover as much value as possible from these materials at the end of their useful life.

If the above methods of disposal are unsuccessful or deemed inappropriate, the Procurement Office, in consultation with the Regional Department responsible for the asset will determine the most appropriate method of disposing of the asset in an environmentally sustainable manner.

If the asset is of nominal value, it may be donated for charitable or benevolent purposes at the discretion of the appropriate Commissioner.

#### Disposal proceeds were transferred to replacement reserves

Proceeds from the disposal of surplus assets will be transferred to the appropriate asset replacement reserve, as determined by the Commissioner of Finance.

#### 4. Analysis and Implications

## Vehicles and equipment disposed of in 2017 resulted in revenue of \$328,653

The total value of surplus vehicles and equipment disposed of in 2017 is reflected in Table 1. The proceeds of these disposals were transferred, in full, to the reserve accounts identified in Table 1.

In addition to the proceeds generated from the disposal of surplus assets, the Region donated the following:

- 60 mobile radios from York Regional Police to the Consul General of Saint Lucia for their hurricane recovery efforts in Saint Lucia, Antigua, and Barbuda,
- Three decommissioned ambulances as approved by Council on <u>June 23, 2016</u>. Two of these ambulances were donated to St. John's ambulance of York Region to support volunteer efforts in York Region, and the third one was donated to the Caribbean North Charities Foundation to support St. Jude Hospital in Vieux Fort, St. Lucia, and;
- Surplus restorative dentist equipment to Smiles Foundation, a Canadian charitable organization that provides free and affordable

dental care and primary health education to underprivileged children and their families in the Dominican Republic.

#### 5. Financial Considerations

Proceeds from the disposal of surplus assets have been transferred to the respective departments' asset replacement reserves.

#### 6. Local Municipal Impact

There is no local municipal impact associated with this report. No local municipalities expressed an interest in acquiring any of the assets identified in this report at their net residual value.

#### 7. Conclusion

The surplus assets identified in this report were disposed of in accordance with the Region's Disposal of Surplus Assets Policy. A total of \$328,652.58 in proceeds was generated through the disposal of these surplus assets.
