





# Designated Greenfield Area Density Target Phased In








New Community Areas in York Region are now subject to the Official Plan target of 70 residents and jobs per hectare

# **Intensification Target Phased In**



York Region is **well positioned to deliver the targets** having achieved an average of **48%** intensification over the last 10 years

# **Importance of Major Transit Station Areas Strengthened**

- Density targets apply to MTSAs on Priority Transit Corridors only
- Averaging density targets across Priority Transit Corridors is permitted
- Council may request alternative MTSA targets



Most of York Region's MTSAs are located within Priority Transit Corridors


# **Planning for Employment**

- Regional employment strategy and designation of employment areas required
- Conversions of employment lands considered only at the time of a Regional MCR
- Major retail not permitted in prime employment



Integrating Infrastructure

- Yonge Street subway extension not identified
- Highway 400-404 link added
- Agricultural system supported
- Increased opportunities:
  - Goods movements
  - Separation of modes
  - Inter-modal linkages




Infrastructure planning, investment, and land use planning are to be **coordinated** to implement the Growth Plan

**Increasing Housing Affordability** 

Regional housing strategy required

 Targets to address affordable ownership and rental housing

 Existing housing stock to be considered



The **Housing Working Group** is well positioned to provide input on housing requirements

**Addressing Climate Change** 

 Official Plans must include climate change policies

- Setting greenhouse gas emission targets is encouraged
- Move towards low-carbon communities



A Climate Change working group is assessing significant new municipal requirements around Climate Change

# **Supporting Agriculture**

- Agricultural system including mapping to be released by end of 2017
- Agricultural policies align with Provincial Policy Statement 2014
- Exemptions provided for some detailed technical study requirements





York Region **Agricultural Strategy** will support the agricultural system policies

# Protecting Natural Heritage & Water

- Province to map Natural Heritage System by end of 2017
- Within Settlement areas official plan natural heritage systems policies will apply
- Settlement area expansions require policies in official plans to ensure
  - Protection
  - Restoration
  - Enhancement
