## 12 Open Data Program Update

Committee of the Whole recommends adoption of the following recommendations contained in the report dated October 27, 2015 from the Commissioner of Corporate Services:

### 1. Recommendation

It is recommended that Council receive this report for information.

### 2. Purpose

This report provides a summary of progress on York Region's Open Data program and outlines the plan to move forward. Attachment 1 provides an update on data released to date and data identified for release through to 2018.

### 3. Background

### Open Data releases government data for public use

Open data is the release of easy to access government data by anyone for use in new and innovative ways. Making government data available enables the public sector, private sector businesses and non-government organizations (NGOs) to add value to data, rather than duplicating it, thereby reducing costs.

Open data increases transparency, promotes understanding of government and fosters greater trust by proactively making data broadly available to everyone. It helps to raise the profile of regional government as a self-serve trusted source of data.

## Council approved York Region's Open Data program in 2013

Council approved an Open Data program for York Region and York Region's Open data principles on September 26, 2013.

### 125 datasets have been released with over 10,000 downloads

In York Region, open data can be accessed twenty-four hours a day, seven days a week from <u>www.york.ca/opendata</u>. This site provides program information, the open data license agreement and a link to the catalogue of published open data.

There are now 125 datasets released including core mapping datasets (roads, addresses and parcels). Also available are public health inspection results, transit routes and schedules, population estimates and the Region's Operating Budget. Attachment 1 provides a complete list of the data released to date and data identified for release through 2018.

Data has been downloaded over 10,000 times. The most downloaded data are roads, parcels, address points and contour mapping data. Table 1 lists the number of downloads from the Open Data site by year.

## A publication process for release is in place to protect privacy

Datasets to be published on the Open Data site are reviewed for privacy, confidentiality and intellectual property restrictions. A team of representatives from all Regional departments reviews each candidate dataset to determine if the value of releasing the data warrants the publication effort, recommends communications required and facilitates the review process within each department.

The value to release data is determined by the known or expected use of the data including formal requests for the data and/or the elimination of staff effort for repetitive data delivery. Data descriptions are prepared and published with the data, helping users understand the data being released and reducing the likelihood of misinterpretation.

## 4. Analysis and Options

## York Region's open data has been used by the PanAm and ParaPanAm Games and others

York Region's open data was used extensively by the PanAm and ParaPanAm games. It was essential for the creation of map packages provided to athletes, officials and volunteers. It also supported interactive mapping applications such as the Torch Relay map which received over 10,000 daily visits from the public.

York Region's Open Data site helped PanAm's organizers meet tight deadlines, saving staff time associated with data use agreements and data delivery. PanAm organizers commented "York Region's Open Data site was well organized and maintained, and unique in providing high value foundational data such as parcels, address points and roads."

A new start-up company, MapYourProperty (MYP) uses more than 70 percent of York Region's open data including property lines, addresses and contours. MYP combines York Region's data with planning data from the Ministry of Natural Resources and City of Toronto into one application for condominium and home developers, engineering and planning consultants as well as real estate law firms across the GTA. MapYourProperty's tool, created with this open data, streamlines the review of regulatory information for the planning and development community.

# York Region data is used in popular websites, navigation systems and mobile apps for responsive public service

York Region's open data is available to the public through popular websites and GPS navigation systems. York Region's road network, solid waste facilities and other map layers are regularly used as a source to update Google Maps. York Region's transit routes, schedules and vehicle locations are integrated into Google Map's transit directions and trip planning used by the public.

TomTom, an international company which produces data and applications for navigation and routing, uses York Region data on a regular basis to research and resolve addressing and other issues reported by users. In 2014, TomTom added approximately 490 kilometers of roads to their data using York Region open data.

TomTom's data improvements were incorporated into RouteMatch, a third party application used by York Region's Mobility Plus program for trip planning. These data improvements resulted in reduced distance travel time for Mobility Plus trips.

#### **Open Data Program Update**

Open Data has provided YorkSafe's food premise inspection results to Yelp, a local business search tool which publishes crowd-sourced reviews. York Region is working with Yelp and popular review companies to make it easier for the public to access inspection results. Including public health inspection results in Yelp and other popular review sites, as available in the United States, provides the opportunity to extend the public reach of inspection results to Yelp's larger audience, and improve the compliance of food establishments with safe food-handling practices.

## The Provincial and Federal Governments are moving ahead with Open Government and Open Data Directives

The Provincial and Federal governments are moving ahead with open data directives as part of overall Open Government Action Plans. The Province's new draft Open Data Directive instructs Ontario Ministries and Provincial agencies to make data public, unless it is exempted for privacy, legal, security or commercially sensitive reasons.

The Federal government's Open Data directive came into effect in October 2014 with the goal that: "Canadians are able to find and use Government of Canada information and data to support accountability, to facilitate value-added analysis, to drive socio-economic benefits through reuse, and to support meaningful engagement with their government."

## York Region has been invited to participate on the annual Go Open Event

Go Open, now in its fourth year, has been an annual community-driven event that brings together government, non-profits, businesses and academics to build awareness of open data in Ontario. York Region has been invited to participate with ventureLAB, Seneca College, York University, City of Markham, Town of Newmarket, the Province of Ontario and local libraries to host the 2016 event in York Region. Go Open 2016 provides the opportunity to build engagement with the public, focus on the economic benefits and innovative uses of open data and foster partnerships between the Region's technology and business communities.

### A five year plan identifies each department's datasets for release

York Region's Open Data release plan, reviewed annually, has been updated through consultations with each department. The focus is to release datasets of known or demonstrated value with immediate priority given to those already available to the public. The Open Data release plan, (attachment 1) identified data to be released from 2013 to Q3 2015 and what is to be released for the remainder of 2015 to 2018.

## Link to key Council-approved plans

*Vision 2051* addresses open data in the Open and Responsive Government section: "Facilitating information sharing and open data so the broader community can benefit and add value to data collected and maintained by government without restrictions on how it is used."

In the Council approved 2015 to 2019 Strategic Plan, releasing additional data on the Open Data site supports the Key Regional Performance Measure: "Increase number of datasets available" under the Strategic Priority Area of "providing responsive and efficient public service".

## 5. Financial Implications

The Open Data program is funded under the Geographic Information Services Branch in the approved 2015 Corporate Services operating budget.

## 6. Local Municipal Impact

York Region works collaboratively with local municipalities who report value in the ready access to York Region's data through the Open Data site. York Region staff support local municipalities that are interested in open data by sharing best practices and lessons learned.

## 7. Conclusion

The Open Data program makes York Region's data easily available to the public, other government agencies and the private sector. It helps raise the profile of regional government as a self-serve trusted source of data. The over 10,000 downloads since the Open Data site was launched indicates the community finds the self-service approach to accessing data useful. Additional datasets will be reviewed and released to popular sites and applications used by the public.
