2394742 Ontario Inc. operating as Seasons Foodmart Located at 7181 Yonge Street, Unit 336 *Retail Business Holidays Act Application* for Exemption

Committee of the Whole held a public meeting on September 10, 2015, pursuant to the Retail Business Holidays Act, to consider a proposed bylaw to permit the following retail business establishment to remain open on the holidays and hours set out in Recommendation 4, and recommends:

- 1. Receipt of the report dated August 14, 2014 from the Chief Planner and Regional Solicitor.
- 2. Receipt of the deputation by Lauren Chee-Hing, Aird & Berlis LLP on behalf of Seasons Foodmart.
- 3. Receipt of the communication from Li Qin, resident of the City of Vaughan, dated August 18, 2015.
- 4. Permitting 2394742 Ontario Inc. operating as Seasons Foodmart located at 7181 Yonge Street, City of Markham to remain open on New Year's Day, Family Day, Good Friday, Victoria Day, Canada Day, Labour Day and Thanksgiving Day between 9 a.m. and 11 p.m. pursuant to the Retail Business Holidays Act.
- 5. The Regional Solicitor prepare the necessary bylaw giving effect to the exemption.

1. Recommendations

It is recommended that:

 Council consider the application for exemption from the *Retail Business Holidays Act* as submitted by 2394742 Ontario Inc. operating as Seasons Foodmart (the "Applicant") for its retail business Seasons Foodmart located at 7181 Yonge Street in Markham, Ontario.

- 2. Council determine whether to grant an exemption from the *Retail Business Holidays Act* to allow the Applicant to remain open on New Year's Day, Family Day, Good Friday, Victoria Day, Canada Day, Labour Day and Thanksgiving Day.
- 3. A bylaw be presented to give effect to the exemption, if granted by Council.

2. Purpose

This report advises Council of an application for exemption from the *Retail Business Holidays Act* to allow the Applicant to be open on certain statutory holidays. This application is the subject of the public meeting to be held on September 10, 2015.

3. Background

The *Retail Business Holidays Act* requires businesses to be closed on certain statutory holidays

The *Retail Business Holidays Act* (the "Act") requires businesses to be closed on public holidays unless they are exempted. The holidays to which the Act applies are:

- New Year's Day
- Family Day
- Good Friday
- Easter Sunday
- Victoria Day
- Canada Day
- Labour Day
- Thanksgiving Day
- Christmas Day

Boxing Day and the Civic Holiday in August are not public holidays under this Act and therefore an exemption is not required for those days.

The Act sets out statutory exemptions for certain types of businesses and also provides that Council may permit businesses to remain open for the maintenance or development of tourism. A public meeting must be held to consider the application.

The following application has been received:

In accordance with the Act, notice of a public meeting was advertised in the Markham Economist and Sun and the Thornhill Liberal on August 6, 2015 and was posted on the Region's website.

A copy of the application with supporting documentation is appended to this report as Attachment 2.

Exemption under the Act

Businesses are exempt under the Act if the only goods available for sale on the holiday are foodstuffs, tobacco, antiques or handicrafts. These businesses shall not exceed three employees and the total area used for service shall be less than 2, 400 square feet. Other businesses which are exempt are businesses selling only gasoline, nursery stock/flowers or fresh fruit and vegetables.

The Act does not apply to pharmacies as they are governed under the *Drug and Pharmacies Regulation Act* and the selling of liquor is governed under the *Liquor License Act*.

Council may permit businesses to be open on holidays if the tourism criteria are met

The Act provides that Council may permit retail business establishments to open on holidays for the maintenance and development of tourism.

A bylaw may be passed only if there is compliance with the tourism criteria set out in Ontario Regulation 711/91 *Tourism Criteria* (the "Regulation") under the Act. A copy of the regulation is appended to this report as Attachment 3. In addition, even if the tourism criteria are met, Council is not required to pass the bylaw and may exercise its discretion to refuse the application.

Section 2 of the Regulation provides that a business can be exempted if:

- It is located within two kilometres of a tourist attraction; and
- Is directly associated with the tourist attraction or relies on tourists visiting the attraction for business on a holiday.

For the purposes of Section 2, a tourist attraction is limited to:

- Natural attractions or outdoor recreational attractions;
- Historical attractions; and
- Cultural, multi-cultural or educational attractions.

4. Analysis and Options

The Applicant has been active and present in the Region for one year and is located along Yonge Street in proximity to Grandview Park and Winding Lane Park as noted in the Applicant's submission

The Applicant has been present and active in the Region since 2014. The Applicant is a supermarket totalling 44,015 square feet and has been in operation for one year employing 36 employees. The operating hours are currently 9:00 a.m. to 11:00 p.m.

The Applicant has submitted an application to open on the following statutory holidays: New Year's Day, Family Day, Good Friday, Victoria Day, Canada Day, Labour Day and Thanksgiving Day.

The Applicant lists Grandview Park and Winding Lane Park as the tourist attractions within its vicinity

The Applicant has listed Grandview Park and Winding Lane Park as the tourist attractions on this application. The Applicant is within 574.45 metres of Grandview Park and 683.45 metres of Winding Lane Park, and as illustrated on the Municipal Location Map - Attachment 1. The Applicant therefore meets the location criteria for exemption consideration.

In addition to submitting an application, the Applicant has provided customer surveys and a petition signed by its employees supporting this application (see Attachment 2).

The Applicant's submission states, "The Parks are open throughout the entire year and are well-known destinations for families. Both Parks include amenities which would attract tourists to the areas especially during a holiday. The woodlot located in Grandview Park certainly attracts tourists interested in nature watching and the local wildlife. Both Parks have abundant open space for large picnics, walks, soccer games and other community events. The Applicant has advised it is common for visitors to both parks to purchase their picnic, food and refreshment supplies at Seasons Foodmart which is located to attract visitors from the surrounding area due to its geographic proximity to the parks."

Currently there are no bylaws applicable to this business, but there is one business area, in proximity to the Applicant's location in the Thornhill Area in the City of Vaughan, which was granted an exemption for Good Friday and Easter Sunday in September 2014. A chart showing businesses within the Region which have been granted an exemption is appended to this report as Attachment 4.

Enactment of Bylaw

Should Council decide to grant the exemption, the bylaw will come into force on the thirty-first day after it is enacted. Under the Act, there is a period to allow for an appeal of the bylaw which may be made within thirty days, by any person who objects to the exemption. An appeal may only be made if an exemption has been granted. If there is no appeal, the bylaw takes effect on the thirty-first day after it is passed.

5. Financial Implications

There are no direct financial implications to the Region as a result of this application.

6. Local Municipal Impact

Approval of an exemption under the Act is intended to contribute to tourism in a particular location, in this case in the City of Markham. A copy of the application was sent to the City of Markham Clerk's Office, on July 23, 2015, for comment.

7. Conclusion

An application has been received from the Applicant requesting an exemption from the Act to permit the Applicant's retail business located at 7181 Yonge Street to remain open on New Year's Day, Family Day, Good Friday, Victoria Day, Canada Day, Labour Day and Thanksgiving Day.

Council is respectfully requested to review this application and determine whether to enact an exempting bylaw, with due consideration to the criteria set out in the Regulation.

If Council elects to pass a bylaw, the bylaw will come into effect on October 26, 2015.



Re: Application by 2394742 Ontario Inc. (Seasons Foodmart) Tourism Exemption under Retail Business Holidays Act 7181 Yonge Street, Unit 336, Thornhill, Ontario

We are legal counsel to 2394742 Ontario Inc. (Seasons Foodmart) (the "Applicant"), the owner of 7181 Yonge Street, Unit 336 (the "Site"), in its application for exemption under the *Retail Business Holidays Act*, R.S.O. 1990, c. R.30. The Applicant operates a supermarket which provides diversified products and services to meet the needs of its multi-cultural clientele.

It is our submission that the Site properly fulfills the criteria for exemption as set out under subsections 2(1) and 2(3) of O. Reg. 711/91 made pursuant to the *Retail Business Holidays Act*:

- 2. (1) A retail business establishment may be exempted if,
 - (a) it is located within two kilometres of a tourist attraction; and
 - (b) it is directly associated with the tourist attraction or relies on tourists visiting the attraction for business on a holiday.

(3) For the purposes of this section, a tourist attraction is limited to,

- (a) <u>natural attractions</u> or <u>outdoor recreational attractions;</u>
- (b) historical attractions; and
- (c) cultural, multi-cultural or educational attractions. (emphasis added)

In particular, the Site is located a mere 574.45 metres from Grandview Park located on Grandview Avenue, west of Henderson Road. Grandview Park has an area of 3.25 hectares and encompasses two baseball diamonds, two tennis courts, a playground and a woodlot.

In addition, the Site is also located in close proximity to Winding Lane Park which is located on Yorkhill Boulevard and only 683.45 metres from the Site. Winding Lane Park has an area of 4.18 hectares and has a playground and basketball court.

In this regard, please find attached a Google Map image showing the distance between the Site and Grandview Park and Winding Lane Park (collectively the "Parks"). Both Parks are tourist attractions that are "natural attractions or outdoor recreational attractions" (s. 2(3)(a) of O. Reg. 711/91).

The Parks are open throughout the entire year and are well-known destinations for families. Both Parks include amenities which would attract tourists to the areas especially during a holiday. The woodlot located in Grandview Park certainly attracts tourists interested in nature watching and the local wildlife. Both Parks have abundant open space for large picnics, walks, soccer games and other community events.

The Applicant has advised that it is common for visitors to both Parks to purchase their picnic, food and refreshment supplies at Seasons Foodmart which is well located to attract visitors from the surrounding area due to its geographic proximity to the Parks. The Site is directly accessible from Yonge Street which is one of the main arterial roads to reach both Parks. Tourist traffic will undoubtedly access Yonge Street to reach or exit from the Parks.

In 2013, the Region of York enacted By-law 2013-67 and By-law 2013-27, which approved applications for exemption under the *Retail Business Holidays Act* for two supermarkets also located in the City of Markham, Sunny Foodmart and Foody Mart, respectively. Council for York Region approved both applications on the same grounds which are present in this application. The application by Sunny Foodmart listed Milne Dam Conservation Park and Rouge Park National Urban Park as tourist attractions within two kilometres. Similarly, the application by Foody Mart listed Milne Dam Conservation within two kilometres.

The Applicant has taken great care to ensure that the community is desirous of its application. Attached are surveys indicating support from the community as well as numerous signatures indicating staff support for an exemption from the *Retail Business Holidays Act*.

In view of the foregoing, it is our opinion that the application fulfills the criteria as indicated in the *Retail Business Holidays Act* and O. Reg. 711/91. We trust that York Region will apply the same treatment and provide the same consideration to our client as it has given to other similarly-situated businesses on other applications for exemptions.





ONTARIO REGULATION 711/91

TOURISM CRITERIA

Consolidation Period: From December 1, 1991 to the e-Laws currency date.

No amendments.

This Regulation is made in English only.

1. This Regulation sets out the tourism criteria that must be met before a municipality may pass an exempting by-law under subsection 4 (1) of the Act . O. Reg. 711/91, s. 1.

- 2. (1) A retail business establishment may be exempted if,
 - (a) it is located within two kilometres of a tourist attraction; and
 - (b) it is directly associated with the tourist attraction or relies on tourists visiting the attraction for business on a holiday. O. Reg. 711/91, s. 2 (1).
- (2) An exemption granted on an area basis may only be given if,
 - (a) all of the retail business establishments in the area are within two kilometres of the tourist attraction;
 - (b) the area does not exceed that necessary to encompass all of the retail business establishments for which an exemption is sought; and
 - (c) at least 25 per cent of the retail business establishments in the area are directly associated with the tourist attraction or rely on tourists visiting the attraction for business on a holiday. O. Reg. 711/91, s. 2 (2).
- (3) For the purposes of this section, a tourist attraction is limited to,
 - (a) natural attractions or outdoor recreational attractions;
 - (b) historical attractions; and
 - (c) cultural, multi-cultural or educational attractions. O. Reg. 711/91, s. 2 (3).

3. Each retail business establishment that on days other than holidays normally uses a total area of 2,400 square feet or more for serving the public or normally has four or more employees serving the public must, in addition to meeting the tourism criteria set out in subsection 2 (1), provide goods or services on holidays primarily to tourists. O. Reg. 711/91, s. 3.

4. The two kilometre restriction set out in subsections 2 (1) and (2) does not apply to a retail business establishment located in a local municipality, including a local municipality located in a district or regional municipality or the County of Oxford, having a population of less than 50,000. O. Reg. 711/91, s. 4.

5. (1) Despite any other provision of this Regulation, retail business establishments in a municipality may be exempted for up to five holidays a year during which a fair, festival or other special event is being held in that municipality. O. Reg. 711/91, s. 5 (1).

(2) Subsection (1) does not apply to parades. O. Reg. 711/91, s. 5 (2).

6. (1) An application for an exemption under subsection 4 (3) of the Act shall contain the following:

1. A description of the area or the retail business establishment for which the exemption is sought.

- 2. The justification, in relation to the seasonal nature, if any, of the tourist attraction, for the time period sought in the exemption.
- 3. Information establishing that the tourism criteria set out in this Regulation are met. O. Reg. 711/91, s. 6 (1).

(2) An application in respect of a retail business establishment described in section 3 shall be made only by that retail business establishment. O. Reg. 711/91, s. 6 (2).

RETAIL BUSINESS HOLIDAYS ACT EXEMPTIONS

Retail Business Holidays Act provides for the following "holidays": New Year's Day, Family Day, Good Friday, Easter Sunday, Victoria Day, Canada Day, Labour Day, Thanksgiving Day, Christmas Day and any other day proclaimed by the Lieutenant Governor. Table showing Schedule A of Bylaw LI-8-95-76 being a Bylaw to permit retail business establishments to be open on holidays. Includes subsequent amendments.
