
Greater Toronto Area Greenlands Study (the Kanter Report) 1990

Geographic Extent of the Plans




Geographic Impact of the Plans in York Region

69% Greenbelt and Oak Ridges Moraine

11% Urban, Towns & Villages, Hamlets

58% Agricultural & Environmental Land

2015 Plan Reviews - Scope

Oak Ridges Moraine Act and Greenbelt Act:


- Assess effectiveness of Plans
- Determine if any revisions should be made
- Include consultation
- Cannot remove land from Natural Core Areas or Natural Linkages Areas of ORM
- Cannot reduce the total land area of the Greenbelt Plan

Places to Grow Act:

- Determine whether the Plan should be revised
- Consult with Provincial Ministries, municipalities and the public

The Region is one of many stakeholders in these reviews

Phase 1: Proactive Consultation



Extensive preliminary consultation was conducted on the Greenbelt Plan and ORMCP

Phase 1: Preliminary Input

- The Region requested that the Province:
 - Co-ordinate the review of the Growth Plan with the ORMCP and Greenbelt Plan
 - Conduct comprehensive consultation
- The following areas were identified for Provincial review in 2015:

Providing Infrastructure





Phase 2: Responding to the Provincial Process



The Region is committed to conducting a balanced review of the Provincial Plans

Phase 2: Key Issues & Opportunities



A number of concerns brought forward prior to adoption of the *Greenbelt Plan* in 2005 remain unchanged after 10 years

Consultation Process

- Staff participated in a wide range of consultation activities
- Regional staff ensured awareness and involvement of community members and stakeholders throughout review
- A comprehensive consultation process is requested for Phase 2

Consultation confirmed support for areas identified through proactive consultation

Supporting Environmental Principles

- 'Stay the Course' by maintaining integrity of Plans, including protecting Natural Core and Natural Linkage areas
- Recognize the importance of significant woodlands and urban forest canopy cover, and take a no-net loss approach



Supporting Agricultural Viability

- Enhance the Plans' ability to further promote agricultural viability and a strong rural economy
- Address compatibility challenges at the interface between urban and rural agricultural land uses



Acommodating Long-Term Growth

- Consider a process to allow municipalities to access strategically located employment lands
- 'whitebelt' lands should be reserved for long term growth (beyond 2031)
- Accommodating community facilities









Boundaries

 The Region received site-specific requests for 51 properties regarding boundary adjustments or additional permissions



Categories of Landowner Requests

Process for Employment Lands

The Province is requested to develop a process allowing access to strategic employment lands in certain circumstances

Process for Boundary Confirmation/Adjustment
 The Province is requested to develop a process to confirm or correct boundaries


Input Received


These requests are provided to the Province as input received throughout our review process


The nature of site-specific requests is varied

Implementation & Monitoring

- Consistency with the PPS 2014 and across all provincial plans and Ministries
- Consider imposing a sunset clause for applications transitioned by the Plans
- Place more emphasis on monitoring and reporting
