

Clause 8 in Report No. 6 of Committee of the Whole was adopted, without amendment, by the Council of The Regional Municipality of York at its meeting held on March 12, 2015.

Disposal of Surplus Assets - 2014

Committee of the Whole recommends adoption of the recommendation contained in the following report dated February 6, 2015 from the Commissioner of Finance:

1. Recommendation

It is recommended that:

1. Council receive this report for information.

2. Purpose

The purpose of this report is to advise Council of actions taken by the Director, Supplies and Services, to dispose of surplus vehicles, equipment and a heritage home from January 1, 2014 to December 31, 2014.

3. Background

Council approved Purchasing Bylaw 2014-53 on June 26, 2014. The surplus assets described in this report were disposed of under the provisions of this bylaw and the Disposal of Surplus Assets Policy, adopted by Council on March 27, 2014.

The Director, Supplies and Services, has the authority to transfer surplus assets as declared by the Commissioners from one department to another department, or to a local municipality, and the authority to sell or dispose of such surplus assets or to exchange or trade the same for replacement assets.

Disposal of Surplus Assets - 2014

A report must be submitted annually to Council by the Treasurer to advise of the sale or disposition of surplus assets under section 17 of the Purchasing Bylaw.

4. Analysis and Options

Vehicles, equipment and a heritage home disposed of in 2014 equalled \$240,300.65

The total value of surplus vehicles, equipment and a heritage home disposed of in 2014 was \$240,300.65:

- 33 vehicles for Transportation Services, Fleet Services, in the amount of \$104,852.21
- 8 vehicles for Community and Health Services, Emergency Medical Services, in the amount of \$51,567.10
- Various Equipment for Transportation Services, Fleet Services in the amount of \$54,160.37
- Various Equipment for Transportation Services, Transit Management Systems in the amount of \$20.00
- Various Equipment for Community and Health Services, Emergency Medical Services, in the amount of \$3,500.00
- Various Equipment for Environmental Services, Capital Planning and Delivery in the amount of \$26,199.97
- The Elias Hamilton House, listed on the Markham Register of Property of Cultural Heritage Value or Interest, was sold in an 'As Is' condition for \$1.00. As per the contract, relocation expenses estimated at \$200,000 were the responsibility of the purchaser.

Attachment 1 provides a list of surplus vehicles, equipment and a heritage home disposed of by the Director, Supplies and Services, in 2014.

This report is consistent with the 2015-2019 Strategic Plan's priority area of good government. It supports the Plan's objectives of ensuring a fiscally prudent and efficient Region as well as stewardship of the Region's assets.

5. Financial Implications

Funds from disposal have been credited to the revenue accounts of the respective departments, namely Sale of Equipment or Sundry Revenue.

6. Local Municipal Impact

Local municipalities were advised of the availability of surplus vehicles, equipment and a heritage home at net residual value. One 2003 Freightliner FL-70 Sweeper, was sold to the Town of Georgina for \$32,500.

As useful purposes were not identified for all other surplus assets, they were disposed of in accordance with the Region's Purchasing Bylaw 2014-53 and the Disposal of Surplus Assets Policy.

7. Conclusion

Regional departments and local municipalities were advised of the availability of surplus vehicles, equipment and a heritage home at net residual value. Surplus assets for which useful purposes were not identified were disposed of in accordance with the Region's Purchasing Bylaw 2014-53 and the Disposal of Surplus Assets Policy.

All disposal requests and copies of the notices are retained in the Surplus Property file and reported annually to Committee and Council.
