BYLAW NO. 2014-62

To acquire certain lands for or in connection with the widening and reconstruction of Highway 7 (YR 7) from Verclaire Gate to Sciberras Road, City of Markham

WHEREAS the Council of The Regional Municipality of York on January 23, 2014, by its adoption of Clause 10 of Report 2 of the Committee of the Whole authorized an application for approval to expropriate the lands therein referred to for or in connection with the widening and reconstruction of Highway 7 (YR 7) from Verclaire Gate to Sciberras Road, in the City of Markham; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS two requests for a hearing before an Inquiry Officer were received and subsequently withdrawn; and

WHEREAS the Council of The Regional Municipality of York on September 11, 2014, by its adoption of Clause 41 of Report 13 of the Committee of the Whole approved the expropriation of the hereinafter described lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the lands referred to in section 3 is hereby approved for or in connection with the widening and reconstruction of Highway 7 (YR 7) from Verclaire Gate to Sciberras Road, City of Markham.
