

The Regional Municipality of York has completed a Schedule B Municipal Class Environmental Assessment (Class EA) study to identify the water infrastructure upgrades needed to support approved growth in the community of Stouffville.

As a result of the study, York Region has identified the preferred water storage alternative to upgrade the west cell of the Stouffville Reservoir and rehabilitate the existing Zone 2 Elevated Tank. The study also identified a water supply alternative to maintain the existing system and rehabilitate existing wells as needed.


