Introduction

Long-Term Care Home Requirements

The Fixing Long-Term Care Home Act, 2021 requires every licensed long-term care home in Ontario to have an infection prevention and control program in place that meets the requirements stated in *Ontario Regulation 246/22*. A comprehensive infection prevention and control program that is properly implemented can help prevent the transmission and spread of illness in the long-term care home (LTCH).

This resource package contains information and resources to assist York Region LTCHs in meeting these requirements.

Retirement Home Requirements

The *Retirement Homes Act, 2010* requires every licensed retirement home in Ontario to have an infection prevention and control (IPAC) program in place that meets the requirements stated in *Ontario Regulation 166/11*. A comprehensive IPAC program that is properly implemented can help prevent the transmission and spread of illness in the retirement home.

This document contains information and resources to assist York Region retirement homes in meeting these requirements. Please refer to the Retirement Homes Regulatory Authority, www.rhra.ca for an explanation of the Regulations pertaining to infection prevention and control.

Public Health Inspections

Public Health Inspectors (PHI) conduct food safety inspections at homes that have ten or more residents, and if applicable, inspections of swimming pools, whirlpools and personal service settings, such as hair salons. Public health inspectors also conduct IPAC inspections when an outbreak has been declared and investigate complaints that could be related to a health hazard. The focus of an inspection can include any of the following areas:

- Cleaning and disinfection practices
- General maintenance and sanitation
- Hand hygiene, Routine Practices and Additional Precautions (including use of personal protective equipment)
- Outbreak response and implementation of control measures
- Food safety, water safety and personal services safety
- Complaint follow-up

Food Safety

YorkSafe Food Handler Certification



Licenseses are required to ensure that when food is prepared in the retirement home, at least one person involved in preparing the food holds a current certificate in food handling.

In addition, the *Ontario Food Premises Regulation 493/17*, requires all food service premises to have at least one certified food handler at all times while open.

Food Recalls

York Region uses the RAVE Notification system to provide premises including long term care and retirement homes in York Region with urgent health information in a timely manner regarding food recalls, drinking water advisories, health advisories, heat alerts and other important public health issues.

When a food recall alert is initiated by York Region Public Health, you will receive a notification through email or telephone. We ask that you respond to these notifications as quickly as possible. Your response to the questions will help us determine what actions, if necessary, should be taken and will help us gauge the effectiveness of the recall.

Food Safety Inspections

Homes with 10 or more residents will be inspected three times a year to ensure their kitchen and food safety practices are in line with the *Ontario Food Premises Regulation 493/17*. The home's kitchen and any servery units will be inspected.

If your home is on non-municipal water, water samples will also be taken at each inspection. Communal fridges that store food for residents will also be monitored at these inspections. Please ensure any food brought in for residents is labelled with the resident's name and date the food was put in the fridge. Food for staff should be kept in dedicated employee fridges.

Independent Health Care Providers and Spa Services

If your home has external independent health care provider's come into the home to provide services (e.g., foot care, dental, etc.), a risk assessment and review of their infection prevention and control practices (i.e., audit) is to be completed by the home to ensure the provider is aligned with the current national, provincial and regulatory body standards and/or guidelines.

Homes that offer spa services (e.g., hair salon, manicures, etc.) will be inspected to ensure compliance with best practices for infection prevention and control in personal service settings.

If your home offers manicure services as part of an activation program, please ensure best practices are followed as it relates to tools (e.g., nail clippers, etc.) that are not designed to be single use. Shared tools that have not been cleaned and disinfected can lead to the spread of infections. Proper cleaning and disinfection is important to kill germs that cause infections.

Tools and work surfaces must first be cleaned with water and detergent to remove dirt and debris, then treated with a chemical solution called a disinfectant to kill germs. Bleach and alcohol are examples of common disinfectants.

Policy Review

A vital component of any infection prevention and control program is to have accurate policies available to staff to ensure they can obtain direction on infection prevention and outbreak management at any time.

The [Institutional/Facility Outbreak Management Protocol](#) was updated in 2023, and requires all congregate living settings (i.e., long-term care, retirement homes and group living settings) to review their written policies and procedures for outbreak prevention and response and ensure any recommendations from prior outbreaks and/or infection prevention and control audits are incorporated, at a minimum of every year. This includes a review of general infection prevention and control policies, as well as outbreak prevention and management procedures.

Homes are also responsible to develop, implement and continually review a Water Safety Plan (WSP), more information on this is discussed later in this document in the Water Outage & Safety Plans section.

Respiratory Illness Prevention

Encouraging staff, residents and visitors to protect themselves by learning about the spread of respiratory illnesses and how they can be prevented is very important.

Outbreak Surveillance and Management

According to the current regulation, every home is required to have a surveillance protocol that sets out how the home will identify, document and monitor residents who report symptoms of respiratory or gastrointestinal illness. In addition, written procedures have to be established to ensure infectious disease outbreaks and/or any increases in the number of residents with symptoms are reported to York Region Public Health.



An outbreak may occur when more residents and/or staff experience similar respiratory and/ or enteric symptoms. Early reporting of a suspected outbreak and practicing proper infection prevention and control measures will decrease the number of residents and/or staff who become ill and reduce the outbreak's duration.

Reporting an Outbreak

If you suspect there is an outbreak at your home, notify York Region Public Health, **Infectious Diseases Control Division** immediately using the following options:

- **On-line Form:** Visit [Infectious Diseases and Outbreak Management | York Region](#). In the Gastroenteric or Respiratory Outbreak section, click the “**Outbreak Reporting Form**” button.

The online form provides a fast and effective way to report cases, and it allows facilities to include all relevant information at the time of submission. The form also provides instructions to begin implementing outbreak control measures.

The online reporting form can be used Monday-Friday (excluding statutory holidays) between 8:30 AM and 4:15 PM. To report outbreaks outside of office hours (including weekends and statutory holidays), please contact the on-call investigator using the contact information below.

Outbreak Management

Public Health Teams involved in Outbreak Management

Public health staff from both the Control of Infectious Diseases team (Outbreak Investigators) and the Public Health Inspectors (PHI) from the Health Protection Infection Prevention and Control (IPAC) team will be involved in outbreak management. How each team is involved in your outbreak is described below.

Outbreak Management Meeting

Once an outbreak has been declared in your home, an Outbreak Management Team (OMT) meeting will be conducted with the outbreak investigator, who will provide case and contact management support, the PHI who will provide onsite IPAC guidance, and representatives from your home. The OMT meeting will take place within 24 hours of declaring a confirmed outbreak.

Outbreak Inspection

Once a confirmed outbreak has been declared at your home, a public health inspection will take place to ensure practices are in place to mitigate the spread of illness. An outbreak report will be provided by the PHI and will outline any actions that need to be taken.

Control Measures Assessment Form

If an outbreak inspection cannot take place within 24 hours of a confirmed outbreak being declared, the PHI will email the [Control Measures Assessment Form](#) (CMAF) to you. This form will also be sent for a suspect respiratory outbreak. The CMAF is to be completed within two hours and returned to the PHI. IPAC measures identified on the CMAF need to be implemented at the home immediately to help control the outbreak.

Line Listing and Daily Reporting During an Outbreak

Effective management of outbreaks requires homes to report timely up to date information of symptomatic residents and staff to the outbreak investigator. Your outbreak investigator will email you a package at the start of an outbreak which includes instructions for completing and sending the line list electronically to public health. Line lists need to be sent daily by noon, excluding weekends or statutory holidays. If there is any delay, please notify your outbreak investigator. Please report to our after-hours line (905-953-6478) if there are any urgent concerns or an increase in severity (i.e., increase in cases, hospitalizations or deaths) after-hours, including weekends and statutory holidays.

Homes are required to provide education and training for residents, their substitute decision-maker(s), staff and volunteers on how to prevent transmission and spread of illness. Resources are available on the York Region website to help homes achieve this requirement.

Infectious Diseases and Prevention Reports



York Region public health conducts near real-time epidemiological surveillance on infectious diseases. The following reports can be obtained online by visiting [Health Statistics and Reports | York Region](#) and selecting the ribbon 'Infectious Diseases and Prevention'.

Dashboards are available on; Diseases of Public Health Significance Enhanced Surveillance Dashboard, Integrated Respiratory Dashboard and Institutional Outbreak Summary Dashboard which are updated on daily or weekly basis.

Notification Systems

When Public Health needs to send a message that may be urgent and time-sensitive to our long-term care homes and retirement homes, the communication is sent through a web-based communication platform.

Contacts for each home are taken from our inspection database which is updated by our public health inspectors at each inspection of your home. If there is a change in contacts for your home, please let your public health inspector or liaison know so they can update this information in our system.

Tuberculosis Screening

Homes are required to ensure that each resident is screened for active tuberculosis (TB) either just prior to or within 14 days of commencing residency in the home; unless the resident has been screened within not more than 90 days prior to admission before commencing residency and the documented results of the screening are available. There have been updated guidance based on the Canadian TB Standards 8th Edition which **no** longer requires all residents to have a chest x-ray. Instead, the following criteria will be used to screen residents:

- An assessment of risk factors for likelihood of respiratory TB infection (considering risk factors such as birth or prolonged residence in a high-TB incidence country, close contact with a person with infectious TB, immunocompromising conditions) should be done on or before admission.
- A symptom screen to rule out active TB should be done, preferably prior to admission.
- A posteroanterior and lateral chest x-ray should be performed **only** if a resident is symptomatic, within 90 days prior to admission. The resident should be referred for medical assessment if indicated. If there are concerning findings on either the review of symptoms or the chest x-ray, three sputum specimens should be collected and tested using microscopy and culture prior to admission. Sputum specimens can be collected on the same day, at least one hour apart.

Routine tuberculin skin testing on (or prior to) admission and periodic tuberculin skin tests (such as annually) are not recommended for residents; however we do encourage screening using tuberculin skin tests be offered to those under 65 years old in order to support detection and treatment of latent tuberculosis infection.

Water Outage & Safety Plans

Water Outage Plan

Homes should have a water outage plan detailing the temporary measures that will be put in place in the event of a planned or unplanned situation where the drinking water is affected to ensure the safety of the residents in the home.

The plan should include information on:

- communications that need to take place in the event of a water outage;
- how drinking water will be supplied;
- how food will be prepared;
- how/if dishwashing will take place;
- how hand hygiene and personal hygiene will be performed;
- how laundry will be processed;
- how cleaning and disinfection of environmental surfaces, devices and equipment will be completed;
- any medical procedure considerations;
- pool and/or spa operation;
- personal services operations;
- enhanced surveillance for enteric illnesses and;
- steps to take once the drinking water is available again.

Water Safety Plan

The Ministry of Health has released an updated guidance document which describes ways in which operators can reduce the risk of *Legionella* in their facilities - [Legionella Investigation Reference Document, January 2025](#)

According to the document, the role of owners and operators of water systems include the following:

- Comply with all applicable laws, regulations and requirements related to the maintenance and operations of their facility
- Manage operation and maintenance of water systems; including keeping records (e.g., operation and maintenance records, water flushing regime, etc.)
- Develop and implement a plan for emergency control measures and remediation in the event of a *Legionella* case or outbreak
- Develop, implement and continually review a Water Safety Plan (WSP)

Ensure the WSP follows these steps:

- Describe the building water system(s);
- Identify risks or areas where *Legionella* could grow or spread (potable and non-potable water plumbing features and devices);
- Put into place appropriate control measures;
- Establish procedures for monitoring whether control measures taken are operating as planned;
- Corrective actions to be taken when control measures are not working;
- Confirm that the program is implemented as designed (verification) and that the program effectively controls the hazardous conditions (validation); and
- Ensure there are supporting activities, including documentation, communication and training of relevant staff.

Extreme Weather Conditions

Homes are required to ensure that there are procedures in place for responding to extreme heat and cold weather conditions. York Region public health notifies the public during extreme temperature events that may impact health (such as heat warnings and extreme cold weather) through media releases and social media.



Stakeholders whose clientele may be more vulnerable to extreme heat, such as long-term care and retirement homes, are also directly notified by email when a heat warning or extended heat warning has been issued for York Region. Extra precautions should be taken to reduce the risk of illness that may be experienced by older adults during hot and humid weather. This may include more frequent checks and encouraging residents to stay cool and hydrated.

Animals Residing In or Visiting a Home

Homes may have animals residing on-site or pet visitation programs that provide opportunities for residents to interact with animals. Some homes may also allow residents to own a pet. While the animal-human interactions provide benefits such as companionship and comfort to residents, animals can pose a risk of infectious diseases transmission, such as rabies.



Homes should develop a written policy that includes the following areas:

- Type of animals permitted as resident pets or in the pet visitation program
- Care of pets residing in the home
- Location and care of pet dwellings in the home
- Interaction of animals with residents, including supervision and hand hygiene requirements
- Vaccination requirements and records keeping
- Procedure to report animal bites and scratches

In the event that a resident or staff is exposed to the saliva of an animal through a bite, or is scratched or licked on an area of broken skin, the incident must be reported directly to York Region public health for the appropriate follow-up by calling 1-800-361-5653 ext 4.
